17 **institutions of higher education.** (1) FOR PURPOSES OF THIS SECTION,
18 UNLESS THE CONTEXT OTHERWISE REQUIRES, "PRIVATE INSTITUTION OF
19 HIGHER EDUCATION" MEANS A NOT-FOR-PROFIT COLLEGE OR UNIVERSITY
20 THAT IS NOT PERVASIVELY SECTARIAN AND THAT MAINTAINS ITS PRIMARY
21 PLACE OF BUSINESS IN THE STATE OF COLORADO, THAT OFFERS GENERAL
22 BACCALAUREATE DEGREES IN ARTS AND SCIENCES, AND THAT IS
23 INSTITUTIONALLY ACCREDITED ON THE BASIS OF AN ON-SITE REVIEW IN
24 COLORADO BY ONE OF THE SIX NATIONALLY RECOGNIZED REGIONAL
25 ACCREDITING ASSOCIATIONS OR BY AN ACCREDITING AGENCY DETERMINED
26 BY THE COMMISSION TO BE APPROPRIATE TO ITS EDUCATIONAL PURPOSES
27 AND PROGRAMS.

1 (2) IN ADDITION TO ANY AMOUNT APPROPRIATED PURSUANT TO
2 THIS ARTICLE, THE GENERAL ASSEMBLY SHALL ANNUALLY APPROPRIATE
3 UP TO ONE PERCENT OF THE AMOUNT APPROPRIATED TO THE COLLEGE
4 OPPORTUNITY FUND PURSUANT TO ARTICLE 18 OF THIS TITLE TO THE
5 COMMISSION TO PROVIDE FINANCIAL ASSISTANCE TO STUDENTS WHO ARE
6 ELIGIBLE FOR THE FEDERAL PELL GRANT AND WHO ATTEND PRIVATE
7 INSTITUTIONS OF HIGHER EDUCATION."
