HB04-1003 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 4, after line 26, insert the following:

2 "SECTION 6. 24-75-102, Colorado Revised Statutes, is amended
3 BY THE ADDITION OF A NEW SUBSECTION to read:

4 **24-75-102. Appropriations expended, when - balance - repeal.**

5 (4) (a) ANY MONEYS APPROPRIATED TO ALL DEPARTMENTS OF STATE
6 GOVERNMENT FOR THE 2003-04 FISCAL YEAR THAT WOULD OTHERWISE
7 REVERT TO THE GENERAL FUND PURSUANT TO SUBSECTION (1) OF THIS
8 SECTION SHALL BE TRANSFERRED BY THE STATE TREASURER TO THE
9 CAPITAL CONSTRUCTION FUND CREATED IN SECTION 24-75-302; EXCEPT
10 THAT THIS AMOUNT SHALL NOT EXCEED ONE HUNDRED FIFTY-TWO
11 THOUSAND EIGHT HUNDRED DOLLARS (\$152,800). THIS TRANSFER SHALL
12 TAKE PLACE PRIOR TO A TRANSFER MADE PURSUANT TO SECTION
13 24-75-218.

14 (b) THIS SUBSECTION (4) IS REPEALED, EFFECTIVE SEPTEMBER 1,
15 2004."
