A BILL FOR AN ACT

101 **CONCERNING SUBSTANCE ABUSE TREATMENT UNDER THE "COLORADO**
102 **MEDICAL ASSISTANCE ACT".**

Bill Summary

(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)

Adds outpatient substance abuse treatment as an optional service to the medical services program ("program"). Requires the state auditor to report to the legislative audit committee on whether the provision of substance abuse treatment services has resulted in an increase or decrease in the overall cost of the program. If the legislative audit committee adopts a resolution finding that the provision of substance abuse treatment resulted in an increase in cost to the program, repeals provisions adding it to the program.

Capital letters indicate new material to be added to existing statute.

Dashes through the words indicate deletions from existing statute.

2 **SECTION 1.** Part 5 of article 4 of title 26, Colorado Revised
3 Statutes, is amended BY THE ADDITION OF A NEW SECTION to
4 read:

5 **26-4-534. Outpatient substance abuse treatment - report of**
6 **state auditor - amendment to state plan - repeal.** (1) (a) ON OR
7 BEFORE JANUARY 1, 2006, THE STATE DEPARTMENT SHALL AMEND THE

13 ANALYZING THE COSTS AND SAVINGS TO THE MEDICAL ASSISTANCE
14 PROGRAM OF PROVIDING OUTPATIENT SUBSTANCE ABUSE TREATMENT.

15 (b) ON OR BEFORE MARCH 31, 2011, BASED UPON THE REPORT
16 REQUIRED BY PARAGRAPH (a) OF THIS SUBSECTION (2), IF THE LEGISLATIVE
17 AUDIT COMMITTEE ADOPTS A RESOLUTION FINDING THAT PROVIDING
18 OUTPATIENT SUBSTANCE ABUSE TREATMENT HAS RESULTED IN AN
19 OVERALL INCREASE IN COSTS TO THE MEDICAL ASSISTANCE PROGRAM,

3 (u) (I) OUTPATIENT SUBSTANCE ABUSE TREATMENT.

4 (II) ON OR BEFORE MARCH 31, 2011, PURSUANT TO SECTION
5 26-4-534 (2), IF THE LEGISLATIVE AUDIT COMMITTEE ADOPTS A
6 RESOLUTION FINDING THAT PROVIDING OUTPATIENT SUBSTANCE ABUSE
7 TREATMENT HAS RESULTED IN AN OVERALL INCREASE IN COSTS TO THE
8 MEDICAL ASSISTANCE PROGRAM, THIS PARAGRAPH (u) IS REPEALED,
9 EFFECTIVE JULY 1, 2011.

10 **SECTION 3. Safety clause.** The general assembly hereby finds,
11 determines, and declares that this act is necessary for the immediate
12 preservation of the public peace, health, and safety.
