SENATE JOINT RESOLUTION 05-038

101 CONCERNING A REAFFIRMATION BY THE COLORADO GENERAL  
102 ASSEMBLY OF THE STRONG BONDS CONNECTING THE UNITED  
103 STATES AND THE STATE OF ISRAEL AND AN EXPRESSION BY THE  
104 COLORADO GENERAL ASSEMBLY OF SUPPORT AND SOLIDARITY  
105 WITH THE STATE OF ISRAEL IN ITS STRUGGLE AGAINST  
106 TERRORISM.

1 WHEREAS, On November 29, 1947, the United Nations General  
2 Assembly voted to partition the British mandate of Palestine and, by that  
3 vote, created the state of Israel; and

4 WHEREAS, On May 14, 1948, the people of the state of Israel  
5 proclaimed the establishment of the sovereign and independent state of  
6 Israel; and

7 WHEREAS, The United States government recognized the state  
8 of Israel just minutes after its declaration of independence and, at that  
9 time, established full diplomatic relations with the nascent state; and

1           WHEREAS, The establishment of the state of Israel as a modern  
2 homeland for the Jewish people followed the extermination of more than  
3 six million European Jews during the Holocaust; and

4           WHEREAS, Since its establishment fifty-seven years ago, the  
5 Israeli people have built a modern nation, forged a new and dynamic  
6 society, and created a unique and vital economic, cultural, and intellectual  
7 life while confronting immense pressures and burdens associated with  
8 war, terrorism, ostracism from much of the international community, and  
9 economic boycotts; and

10           WHEREAS, In spite of this severe degree of adversity confronting  
11 them since 1948, including the War of Independence, the Six-Day War,  
12 the Yom Kippur War, and the terrorist attacks of the two Intifadas, the  
13 people of the state of Israel have established a vibrant and functioning  
14 pluralistic and democratic political system that guarantees fundamental  
15 freedoms of speech and of the press, free, fair, and open elections, and  
16 respect for the rule of law; and

17           WHEREAS, At great financial and social cost, Israel has absorbed  
18 several millions of immigrants from many nations around the world and  
19 has made great strides in fully integrating these immigrants into Israeli  
20 society; and

21           WHEREAS, For over half a century, the people of the United  
22 States and the people of the state of Israel have created and maintained  
23 a special relationship based upon mutually shared democratic values,  
24 common strategic interests, and the bonds of friendship and mutual  
25 respect; and

26           WHEREAS, The bonds connecting the United States and Israel  
27 include increased economic ties between the two nations, particularly  
28 increased trade between Colorado and Israel as evidenced by the  
29 following facts: In 2003, Colorado exported approximately \$38 million  
30 worth of goods to Israel; total Colorado exports to Israel have exceeded  
31 \$250 million since 1991; in 2003, Israel ranked as Colorado's 21st leading  
32 trade partner; and collaboration between Colorado-based and Israeli  
33 business concerns is taking place in, among other things, the areas of  
34 advanced technology, telecommunications, and health care; and

35           WHEREAS, The bonds connecting the United States and Israel  
36 also include greater collaboration between scientific researchers in both  
37 nations, including researchers in Colorado and Israel, and researchers in  
38 Colorado and Israel are collaborating on scientific projects involving,  
39 among other things, atmospheric science, applied chemistry and physics,  
40 medicine, and agriculture; and

41           WHEREAS, The United States also has benefited from the  
42 exchange of technology and expertise from Israel in the area of homeland  
43 security, providing invaluable benefits to our nation in combating and  
44 responding to terrorism; now, therefore,

45           *Be It Resolved by the Senate of the Sixty-fifth General Assembly*

1 *of the State of Colorado, the House of Representatives concurring herein:*

2 (1) That we, the members of the General Assembly of the state of  
3 Colorado, hereby reaffirm the strong bonds that have connected the  
4 people of the United States and the people of the state of Israel together  
5 through turbulent times for more than half a century.

6 (2) That we commend the people of the state of Israel for their  
7 remarkable achievements in building a democratic and pluralistic society  
8 in the wake of almost unrelieved adversity spanning the entirety of the  
9 nation's existence.

10 (3) That we express empathy with the people of the state of Israel  
11 as they endure a daily struggle against terrorism and violence and support  
12 efforts to bring security to the Jewish and democratic state of Israel.

13 (4) That we express outrage against, and in the strongest possible  
14 terms condemn, all acts of terror perpetrated against the Israeli people  
15 with the intent and effect of murdering Israeli civilians, including women  
16 and children.

17 (5) That we support the brave efforts of the government and  
18 people of Israel in pursuing peace by way of negotiation.

19 (6) That we applaud the government of Israel's difficult and  
20 painful decision to disengage from Gaza and the northern section of the  
21 West Bank in order to advance peace negotiations.

22 (7) That we reaffirm the commitment of the American people to  
23 a just, lasting, and secure peace for the people of the state of Israel and  
24 all of the peoples of the Middle East.

25 *Be It Further Resolved,* That copies of this Joint Resolution be  
26 sent to President George W. Bush, Vice President Richard B. Cheney,  
27 Israeli Prime Minister Ariel Sharon, His Excellency Daniel Ayalon, the  
28 Ambassador of Israel to the United States, and to each member of  
29 Colorado's congressional delegation.
