**A BILL FOR AN ACT**

101 **CONCERNING AUTHORIZATION OF A NURSING TEACHER LOAN**  
102 **FORGIVENESS PILOT PROGRAM, AND MAKING AN**  
103 **APPROPRIATION THEREFOR.**

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)*

Authorizes the Colorado commission on higher education to establish a nursing teacher loan forgiveness pilot program ("pilot program") for persons who teach courses in nursing at a Colorado public institution of higher education for a period of at least 5 consecutive academic years after receipt of an advanced degree. Specifies other required conditions for the loan forgiveness. Establishes a fund. Repeals

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** Title 23, Colorado Revised Statutes, is amended BY  
3 THE ADDITION OF A NEW ARTICLE to read:

4 **ARTICLE 3.6**

5 **Nursing Teacher Loan Forgiveness Pilot Program**

6 **23-3.6-101. Definitions.** AS USED IN THIS ARTICLE, UNLESS THE  
7 CONTEXT OTHERWISE REQUIRES:

8 (1) COLLEGEINVEST" MEANS THE AUTHORITY TRANSFERRED TO  
9 THE DEPARTMENT OF HIGHER EDUCATION PURSUANT TO SECTION  
10 23-3.1-203.

11 (2) "PARTICIPATING PRIVATE INSTITUTION OF HIGHER EDUCATION"  
12 MEANS A COLLEGE OR UNIVERSITY THAT IS PARTICIPATING IN THE COLLEGE  
13 OPPORTUNITY FUND PROGRAM CREATED IN ARTICLE 18 OF THIS TITLE.

14 (3) "PROGRAM" MEANS THE NURSING TEACHER LOAN FORGIVENESS  
15 PILOT PROGRAM AUTHORIZED PURSUANT TO SECTION 23-3.6-102.

16 (4) "PUBLIC INSTITUTION OF HIGHER EDUCATION" MEANS A  
17 POSTSECONDARY EDUCATIONAL INSTITUTION ESTABLISHED AND EXISTING  
18 PURSUANT TO LAW AS AN AGENCY OF THE STATE OF COLORADO AND  
19 SUPPORTED WHOLLY OR IN PART BY TAX REVENUES.

20 (5) "QUALIFIED LOAN" MEANS A STUDENT LOAN INCURRED WHILE  
21 EARNING A MASTER'S DEGREE IN NURSING OR A DOCTORAL DEGREE IN  
22 NURSING OR RELATED FIELD FROM A PUBLIC OR PARTICIPATING PRIVATE  
23 INSTITUTION OF HIGHER EDUCATION.

24 (6) "QUALIFIED POSITION" MEANS FULL-TIME EMPLOYMENT BY A  
25 PUBLIC OR PARTICIPATING PRIVATE INSTITUTION OF HIGHER EDUCATION TO

1 TEACH CLASSES REQUIRED TO EARN A DEGREE OR CERTIFICATE IN  
2 NURSING.

3 **23-3.6-102. Nursing teacher loan forgiveness pilot program -**  
4 **administration - fund - conditions.** (1) (a) THE GENERAL ASSEMBLY  
5 HEREBY AUTHORIZES COLLEGEINVEST TO DEVELOP AND MAINTAIN A  
6 NURSING TEACHER LOAN FORGIVENESS PILOT PROGRAM FOR  
7 IMPLEMENTATION BEGINNING IN THE FALL SEMESTER OF THE 2006-07  
8 ACADEMIC YEAR. THE PROGRAM SHALL PROVIDE FOR PAYMENT OF UP TO  
9 TWENTY THOUSAND DOLLARS FOR ALL OR PART OF THE PRINCIPAL OF AND  
10 INTEREST ON A QUALIFIED LOAN IF THE PERSON IS HIRED FOR A QUALIFIED  
11 POSITION AND STAYS IN A QUALIFIED POSITION FOR A PERIOD OF NOT LESS  
12 THAN FIVE CONSECUTIVE ACADEMIC YEARS AFTER THE PERSON EARNED AN  
13 ADVANCED DEGREE IN NURSING. REPAYMENT OF LOANS THROUGH THE  
14 PROGRAM MAY BE MADE USING MONEYS IN THE NURSING TEACHER LOAN  
15 FORGIVENESS FUND, CREATED IN PARAGRAPH (b) OF THIS SUBSECTION (1),  
16 OR MONEYS ALLOCATED TO THE PROGRAM BY COLLEGEINVEST.  
17 COLLEGEINVEST == IS AUTHORIZED TO RECEIVE AND EXPEND GIFTS,  
18 GRANTS, AND DONATIONS OR MONEYS APPROPRIATED BY THE GENERAL  
19 ASSEMBLY FOR THE PURPOSE OF IMPLEMENTING THE PROGRAM. ==

20 (b) THERE IS HEREBY CREATED IN THE STATE TREASURY THE  
21 NURSING TEACHER LOAN FORGIVENESS FUND, WHICH SHALL CONSIST OF  
22 ALL MONEYS APPROPRIATED BY THE GENERAL ASSEMBLY FOR THE  
23 PROGRAM AND ANY GIFTS, GRANTS, AND DONATIONS RECEIVED FOR SAID  
24 PURPOSE. MONEYS IN THE FUND ARE HEREBY CONTINUOUSLY  
25 APPROPRIATED TO THE DEPARTMENT OF HIGHER EDUCATION FOR THE  
26 PROGRAM. ANY MONEYS IN THE FUND NOT EXPENDED FOR THE PURPOSE  
27 OF THIS ARTICLE MAY BE INVESTED BY THE STATE TREASURER AS

1 PROVIDED BY LAW. ALL INTEREST AND INCOME DERIVED FROM THE  
2 INVESTMENT AND DEPOSIT OF MONEYS IN THE FUND SHALL BE CREDITED  
3 TO THE FUND. AT THE END OF ANY FISCAL YEAR, ALL UNEXPENDED AND  
4 UNENCUMBERED MONEYS IN THE FUND SHALL REMAIN IN THE FUND AND  
5 SHALL NOT BE CREDITED OR TRANSFERRED TO THE GENERAL FUND OR ANY  
6 OTHER FUND.

7 (2) IN ADDITION TO ANY QUALIFICATIONS SPECIFIED BY  
8 COLLEGEINVEST, TO QUALIFY FOR THE PROGRAM, A NURSING TEACHER  
9 SHALL:

10 (a) EARN A MASTER'S OR DOCTORAL DEGREE IN NURSING;

11 (b) BE LIABLE FOR AN OUTSTANDING BALANCE ON A QUALIFIED  
12 LOAN;

13 (c) AGREE TO TEACH IN A QUALIFIED POSITION FOR A PERIOD OF  
14 NOT LESS THAN FIVE CONSECUTIVE ACADEMIC YEARS AFTER COMPLETION  
15 OF THE ADVANCED DEGREE;

16 (d) TEACH IN A QUALIFIED POSITION FOR NOT LESS THAN FIVE  
17 CONSECUTIVE ACADEMIC YEARS AFTER COMPLETION OF THE ADVANCED  
18 DEGREE; AND

19 (e) AGREE THAT, IF THE NURSING TEACHER LEAVES THE QUALIFIED  
20 POSITION PRIOR TO TEACHING FOR FIVE CONSECUTIVE ACADEMIC YEARS,  
21 THE NURSING TEACHER SHALL BE LIABLE TO REPAY THE AMOUNT OF THE  
22 QUALIFIED LOAN PAID OR FORGIVEN THROUGH THE PROGRAM PLUS  
23 INTEREST; EXCEPT THAT, IF THE NURSING TEACHER LEAVES THE QUALIFIED  
24 POSITION INVOLUNTARILY, THE NURSING TEACHER SHALL NOT BE LIABLE  
25 TO REPAY THE AMOUNT PAID OR FORGIVEN, BUT SHALL BE RESPONSIBLE  
26 FOR PAYING THE AMOUNT REMAINING DUE ON A QUALIFIED LOAN.

27 (3) THE PROGRAM SHALL PROVIDE THAT, FOLLOWING EACH OF THE

1 FIVE CONSECUTIVE ACADEMIC YEARS THAT THE NURSING TEACHER IS  
2 EMPLOYED IN A QUALIFIED POSITION, THE LESSER OF ONE-FIFTH OR FOUR  
3 THOUSAND DOLLARS OF THE NURSING TEACHER'S QUALIFIED LOAN SHALL  
4 BE PAID OR FORGIVEN.

5 **23-3.6-103. Reporting.** ON OR BEFORE DECEMBER 15, 2008, AND  
6 ON OR BEFORE DECEMBER 15 EVERY TWO YEARS THEREAFTER,  
7 COLLEGEINVEST SHALL PREPARE A REPORT THAT INCLUDES, BUT IS NOT  
8 LIMITED TO, THE NUMBER OF PARTICIPANTS IN THE PROGRAM, THE  
9 AMOUNT OF FUNDS APPLIED TOWARD LOAN REPAYMENT OR FORGIVENESS,  
10 AND THE SOURCES OF THOSE FUNDS. COLLEGEINVEST SHALL PROVIDE THE  
11 REPORT TO THE EDUCATION COMMITTEES OF THE SENATE AND THE HOUSE  
12 OF REPRESENTATIVES, OR ANY SUCCESSOR COMMITTEES. SAID  
13 COMMITTEES SHALL REVIEW THE REPORT AND MAY RECOMMEND  
14 LEGISLATION ON THE PROGRAM.

15 **23-3.6-104. Repeal of article.** THIS ARTICLE IS REPEALED,  
16 EFFECTIVE JULY 1, 2018.

17 **SECTION 2. Appropriation.** In addition to any other  
18 appropriation, there is hereby appropriated, out of any moneys in the  
19 general fund not otherwise appropriated, to the department of higher  
20 education, for allocation to the nursing teacher loan forgiveness fund  
21 created in section 23-3.6-102, Colorado Revised Statutes, for the fiscal  
22 year beginning July 1, 2006, the sum of one hundred sixty-one thousand  
23 six hundred dollars (\$161,600), or so much thereof as may be necessary,  
24 for the implementation of this act.

25 **SECTION 3. Safety clause.** The general assembly hereby finds,  
26 determines, and declares that this act is necessary for the immediate  
27 preservation of the public peace, health, and safety.
