After consideration on the merits, the Committee recommends the following:

SB06-136 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, strike lines 8 and 9 and substitute the  
2 following:

3 "(1) COLLEGEINVEST" MEANS THE AUTHORITY TRANSFERRED TO  
4 THE DEPARTMENT OF HIGHER EDUCATION PURSUANT TO SECTION 23-3.1-  
5 203.";

6 after line 9, insert the following:

7 "(2) "PARTICIPATING PRIVATE INSTITUTION OF HIGHER  
8 EDUCATION" MEANS A COLLEGE OR UNIVERSITY THAT IS PARTICIPATING IN  
9 THE COLLEGE OPPORTUNITY FUND PROGRAM CREATED IN ARTICLE 18 OF  
10 THIS TITLE."

11 Renumber succeeding subsections accordingly.

12 Page 2, strike line 17 and substitute "EARNING A MASTER'S DEGREE IN  
13 NURSING OR A DOCTORAL DEGREE IN NURSING OR RELATED FIELD FROM A  
14 PUBLIC OR PARTICIPATING PRIVATE";

15 line 20, after "PUBLIC", insert "OR PARTICIPATING PRIVATE";

16 line 21, strike "OBTAIN" and substitute "EARN";

- 1 line 24, strike "THE COMMISSION" and substitute "COLLEGEINVEST".
- 2 Page 3, line 5, strike "OBTAINED" and substitute "EARNED";
- 3 line 9, strike the second "THE" and substitute "COLLEGEINVEST";
- 4 line 10, strike "COMMISSION";
- 5 line 11, after "DONATIONS", insert "OR MONEYS APPROPRIATED BY THE  
6 GENERAL ASSEMBLY", and strike "ONLY";
- 7 strike lines 12 through 14.
- 8 Page 4, line 2, strike "THE" and substitute "COLLEGEINVEST,";
- 9 line 3, strike "COMMISSION,";
- 10 line 4, strike "OBTAIN" and substitute "EARN", strike "MASTERS" and  
11 substitute "MASTER'S", and strike "DOCTORATE" and substitute  
12 "DOCTORAL";
- 13 strike line 17 and substitute the following:
- 14 "INTEREST; EXCEPT THAT, IF THE NURSING TEACHER LEAVES THE  
15 QUALIFIED POSITION INVOLUNTARILY, THE NURSING TEACHER SHALL NOT  
16 BE LIABLE TO REPAY THE AMOUNT PAID OR FORGIVEN, BUT SHALL BE  
17 RESPONSIBLE FOR PAYING THE AMOUNT REMAINING DUE ON A QUALIFIED  
18 LOAN."
- 19 strike line 24 and substitute the following:
- 20 "ON OR BEFORE DECEMBER 15 EVERY TWO YEARS THEREAFTER,  
21 COLLEGEINVEST SHALL";
- 22 line 25, strike "AN ANNUAL" and substitute "A".
- 23 Page 5, line 1, strike "THE COMMISSION" and substitute "COLLEGEINVEST"  
24 and strike "NOTICE" and substitute "THE REPORT";
- 25 line 3, strike "COMMITTEES, THAT THE REPORT";

- 1 strike line 4 and substitute the following:
- 2 "COMMITTEES. SAID COMMITTEES SHALL REVIEW THE REPORT AND MAY
- 3 RECOMMEND LEGISLATION ON THE PROGRAM."
