After consideration on the merits, the Committee recommends the following:

SB06-046 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 4, line 18, strike "EDUCATION AND" and
2 substitute "EDUCATION,";

3 line 19, strike "EDUCATION" and substitute "EDUCATION, AND THE EARLY
4 CHILDHOOD SCHOOL READINESS COMMISSION".

5 Page 8, line 1, strike "TWENTY-FIVE" and substitute "TWENTY-NINE";

6 line 2, after "EDUCATION,", insert "THE EARLY CHILDHOOD DEVELOPMENT
7 COMMUNITY,";

8 after line 8, insert the following:

9 "(II) ONE MEMBER WHO REPRESENTS THE GOVERNOR'S OFFICE;

10 (III) ONE MEMBER WHO REPRESENTS THE LIEUTENANT
11 GOVERNOR'S OFFICE;".

12 Renumber succeeding subparagraphs accordingly.

13 Page 8, after line 14, insert the following:

14 "(VII) ONE MEMBER WHO IS A LICENSED MIDDLE SCHOOL OR HIGH
15 SCHOOL COUNSELOR IN COLORADO;".

1 Renumber succeeding subparagraphs accordingly.

2 Page 8, line 19, strike "AND";

3 line 20, strike "SYSTEM;" and substitute "SYSTEM, AND AT LEAST TWO
4 FACULTY MEMBERS FROM A RESEARCH INSTITUTION, STATE COLLEGE, OR
5 THE COMMUNITY COLLEGE SYSTEM;"

6 line 23, strike "TWO" and substitute "THREE".

7 Page 9, line 1, strike "AND";

8 after line 1, insert the following:

9 "(XIII) TWO MEMBERS WHO ARE PARENTS, INCLUDING ONE
10 REPRESENTATIVE OF A STATEWIDE PARENTS' ORGANIZATION; AND".

11 Renumber succeeding subparagraph accordingly.

12 Page 9, line 2, strike "FOUR" and substitute "TWO";

13 line 20, strike "THE" and substitute "IN ADDITION TO CREATING A
14 STATEWIDE P-16 VISION FOR EDUCATION IN COLORADO, THE".

15 Page 10, line 2, strike "AND";

16 after line 2, insert the following:

17 "(f) STRATEGIES TO INCREASE, IMPROVE, AND PROMOTE SCHOOL
18 READINESS PREPARATION FOR CHILDREN UNDER FIVE YEARS OF AGE;

19 (g) STUDYING THE IMPORTANCE AND FEASIBILITY OF
20 COORDINATING STUDENT DATA ACROSS ALL LEVELS OF EDUCATION, AND
21 MAKING RECOMMENDATIONS TO IMPLEMENT ANY PROPOSALS FOR SUCH
22 DATA COORDINATION; AND".

23 Reletter succeeding paragraph accordingly.

24 Page 10, line 11, after "THE", insert "EARLY CHILDHOOD,";

25 line 12, strike "KINDERGARTEN-THROUGH-TWELFTH-GRADE" and
26 substitute "KINDERGARTEN-THROUGH-TWELFTH-GRADE,".

1 Page 11, strike line 13 and substitute the following:

2 "COMPENSATION, BUT THEY MAY RECEIVE REIMBURSEMENT FOR ACTUAL
3 AND NECESSARY EXPENSES FOR DIRECT OR INDIRECT COSTS ASSOCIATED
4 WITH THE DUTIES OF THE P-16 COUNCIL AS SET FORTH IN THIS ARTICLE.
5 SUCH REIMBURSEMENT SHALL COME ONLY FROM AVAILABLE MONEYS
6 APPROPRIATED FROM THE P-16 CASH FUND CREATED IN SECTION 22-88-
7 106.";

8 line 14, strike "2016." and substitute "2010."

9 Page 13, strike line 1 and substitute the following:

10 "(2) COMPENSATION AND REIMBURSEMENT AS PROVIDED IN
11 SECTIONS 22-88-103 (1) (e) (I), 22-88-104 (4),";

12 line 2, after "ASSEMBLY", insert "AND P-16 COUNCIL,";

13 line 15, strike "2016." and substitute "2010."
