After consideration on the merits, the Committee recommends the following:

HB06-1175 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 4, after line 5, insert the following:

2           "(1) "AIRPORT SMOKING CONCESSION" MEANS A BAR OR  
3 RESTAURANT, OR BOTH, IN A PUBLIC AIRPORT WITH REGULARLY  
4 SCHEDULED DOMESTIC AND INTERNATIONAL COMMERCIAL PASSENGER  
5 FLIGHTS, IN WHICH BAR OR RESTAURANT SMOKING IS ALLOWED IN A FULLY  
6 ENCLOSED AND INDEPENDENTLY VENTILATED AREA BY THE TERMS OF THE  
7 CONCESSION."

8 Renumber succeeding subsections accordingly.

9 Page 5, line 5, strike "(4)," and substitute "(5),".

10 Page 9, line 14, strike "FACILITIES" and substitute "FACILITIES, PUBLICLY  
11 OWNED HOUSING FACILITIES,".

12 Page 10, strike lines 20 through 22 and substitute the following:

13           "(f) AN AIRPORT SMOKING CONCESSION;";

14 line 23, strike "BUSINESS." and substitute "BUSINESS;";

15 after line 23, insert the following:

16           "(h) A PLACE OF EMPLOYMENT THAT IS NOT OPEN TO THE PUBLIC

1 AND THAT IS UNDER THE CONTROL OF AN EMPLOYER THAT EMPLOYS THREE  
2 OR FEWER EMPLOYEES; OR

3 (I) A GREYHOUND TRACK, AS DEFINED IN SECTION 12-60-102 (10),  
4 C.R.S."

5 Page 12, line 1, strike "**penalty.**" and substitute "**penalty - disposition of**  
6 **finances and surcharges.**";

7 after line 14, insert the following:

8 "(4) ALL JUDGES, CLERKS OF A COURT OF RECORD, OR OTHER  
9 OFFICERS IMPOSING OR RECEIVING FINES COLLECTED PURSUANT TO OR AS  
10 A RESULT OF A CONVICTION OF ANY PERSONS FOR A VIOLATION OF ANY  
11 PROVISION OF THIS PART 2 SHALL TRANSMIT ALL SUCH MONEYS SO  
12 COLLECTED IN THE FOLLOWING MANNER:

13 (a) SEVENTY-FIVE PERCENT OF ANY SUCH FINE FOR A VIOLATION  
14 OCCURRING WITHIN THE CORPORATE LIMITS OF A CITY, TOWN, OR CITY AND  
15 COUNTY SHALL BE TRANSMITTED TO THE TREASURER OR CHIEF FINANCIAL  
16 OFFICER OF SAID CITY, TOWN, OR CITY AND COUNTY, AND THE REMAINING  
17 TWENTY-FIVE PERCENT SHALL BE TRANSMITTED TO THE STATE  
18 TREASURER, WHO SHALL CREDIT THE SAME TO THE GENERAL FUND.

19 (b) SEVENTY-FIVE PERCENT OF ANY FINE FOR A VIOLATION  
20 OCCURRING OUTSIDE THE CORPORATE LIMITS OF A CITY OR TOWN SHALL  
21 BE TRANSMITTED TO THE TREASURER OF THE COUNTY IN WHICH THE CITY  
22 OR TOWN IS LOCATED, AND THE REMAINING TWENTY-FIVE PERCENT SHALL  
23 BE TRANSMITTED TO THE STATE TREASURER, WHO SHALL CREDIT THE  
24 SAME TO THE GENERAL FUND.";

25 strike lines 21 through 27.

26 Page 13, strike lines 1 through 22.

27 Renumber succeeding sections accordingly.
