After consideration on the merits, the Committee recommends the following:

HB06-1315 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

Amend printed bill, page 2, after line 1, insert the following:

"SECTION 1. Legislative declaration. (1) (a) The general assembly hereby finds that:

(I) Under the existing sentencing laws, a juvenile who is convicted as an adult of a class 1 felony is automatically sentenced to life imprisonment without the possibility of parole, which is the same sentence that applies to an adult who is convicted of a class 1 felony and who does not receive a death sentence;

(II) Persons younger than eighteen years of age may commit crimes that are sufficiently serious, violent, or heinous to warrant punishment in the adult correctional system, and it is in the interest of public safety to ensure that a juvenile who commits an adult-level crime receives an appropriately severe degree of punishment in correlation to the level of crime committed;

(III) Because of their level of physical and psychological development, juveniles who are convicted as adults may, with appropriate counseling, treatment services, and education, be rehabilitated to a greater extent than may be possible for adults whose physical and psychological development is more complete when they commit the crimes that result in incarceration;

(IV) A sentence to lifetime imprisonment without the possibility of parole for a juvenile who is convicted as an adult of a class 1 felony condemns the juvenile to a lifetime of incarceration without hope and, in most cases, without education or rehabilitation services, results in the irredeemable loss of a person to society.

(b) The general assembly finds, therefore, that it is not in the best interests of the state to condemn juveniles who commit class 1 felony crimes to a lifetime of incarceration without the possibility of parole. Further, the general assembly finds that it is in the interest of justice to recognize the rehabilitation potential of juveniles who are convicted as adults of class 1 felonies by providing that they are eligible for parole after serving forty calendar years of their sentences.

(2) (a) The general assembly further finds that:

(I) Under the state constitution, the general assembly has plenary power to enact statutes, except as specifically limited by the people of the state through the constitution;

1 (II) Article III of the state constitution recognizes that the powers
2 of government are divided among the three branches of state government
3 and that persons in one branch of government cannot exercise powers
4 that properly belong to another branch of government;

5
6 (III) Section 7 of article IV of the state constitution specifies that
7 the governor has the power to grant reprieves, commutations, and pardons
8 after conviction of offenses;

9
10 (IV) Other than prohibiting the infliction of cruel and unusual
11 punishments, the constitution does not limit the general assembly's
12 plenary authority to specify the circumstances under which a person who
13 is sentenced to the department of corrections may serve the sentence,
14 including the power of the general assembly to authorize parole;

15
16 (V) The general assembly has statutorily created the department
17 of corrections and the state board of parole and, by statute, has delegated
18 to them the authority to determine the conditions under which an offender
19 who is sentenced to the legal custody of the department of corrections
20 will serve his or her sentence, including the circumstances under which
21 an offender may be released on and serve parole;

22
23 (VI) Prior to adoption of the system of mandatory parole currently
24 applicable to sentences for class 2 through class 6 felony offenses, any
25 period served by an offender on parole constituted a portion of the
26 offender's sentence to incarceration, with the result that parole did not
27 necessarily lessen the length of a sentence, but it changed the
28 circumstances under which the offender served the sentence. An offender
29 who is on parole continues to be in the custody of the department of
30 corrections and continues serving his or her sentence until discharged.
