THE OPERATOR SHALL CONDUCT OIL AND GAS OPERATIONS IN A MANNER THAT REASONABLY ACCOMMODATES THE USE OF THE SURFACE BY THE SURFACE OWNER, AND SHALL EMPLOY REASONABLE MEASURES TO MINIMIZE OR MITIGATE DISTURBANCE AND DAMAGE TO THE SURFACE THAT AFFECT THE VALUE OF THE LAND.
