COMMITTEE OF REFERENCE REPORTS

Appropriations After consideration on the merits, the Committee recommends that **SB06-038** be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation.

Amend printed bill, page 2, after line 10, insert the following:

"SECTION 2. Appropriation. (1) In addition to any other appropriation, there is hereby appropriated, out of any moneys in the division of insurance cash fund, created in section 10-1-103 (3), Colorado Revised Statutes, to the department of regulatory agencies, division of insurance, for insurance fraud prosecution, for the fiscal year beginning July 1, 2006, the sum of three hundred fifty-six thousand nine hundred seventy-four dollars (\$356,974), or so much thereof as may be necessary, for the implementation of this act.

(2) In addition to any other appropriation, there is hereby appropriated, to the department of law, for allocation to the insurance fraud unit, for the fiscal year beginning July 1, 2006, the sum of three hundred fifty-six thousand nine hundred seventy-four dollars (\$356,974) and 5.0 FTE, or so much thereof as may be necessary, for the implementation of this act. Said sum shall be from cash funds exempt received from the department of regulatory agencies out of the appropriation made in subsection (1) of this section.".

Renumber succeeding sections accordingly.

Page 1, line 101, strike "FRAUD." and substitute "FRAUD, AND MAKING AN APPROPRIATION.".

On motion of Senator Mitchell, and with a majority of those elected to the Senate having voted in the affirmative, the following remarks of Senator Hanna and Senator McElhany were ordered spread upon the pages of the journal.

Senator Hanna's remarks:

During the last week I have had a chance to reflect on my action -- the action that you've heard so much about. And I stand before you today offering you my most sincere and heartfelt apology for a lapse in good judgment.

In the aftermath of a very tough campaign, my discussions with the Colorado Association of Realtors was heated and confused. There was miscommunication on both sides.

But, nevertheless, that letter I sent to the Realtor's Small Donor Committee was wrong.

All relationships -- including ours in our business -- should be based on honesty, trust and respect. I felt I was losing those important values in my interactions with them and as a result I wrote that letter in July of 2005.

As I look back and re-read that letter -- which I've done a dozen or more times since last week -- I can clearly see that I used words and phrases that were very inappropriate.

In the heat of a battle, we do and say things that we are not proud of. And this is just such a case.

What I wrote cannot be condoned under any circumstance -- and I have written an apology to the Board of Realtors.

My actions reflect poorly not only upon myself -- but places you, my fellow senators, in a bad light -- and for that I am truly sorry.

To my constituents and all citizens of the State, I ask for your forgiveness for what was a grave misjudgment. I let my emotions overrule good sense.

Like anything in life, when you are wrong -- you apologize -- you learn from it -- and you try not to make that same mistake twice.

I have truly learned from this experience. I am a wiser and much more humble person.

The Senate procedures are in place and I will fully cooperate with that process.

As a person less that perfect -- I humbly apologize to my constituents, to the citizens of this state and to all of you.

Thank you for allowing me these few moments.

Senator McElhany's remarks:

I commend Senator Hanna for apologizing to the body and her constituents. I think what she did is tough to do. None of us would want to be in that position.

But I would also say that it doesn't erase the facts of the case. And I think the thing that most concerns me is the number of times that I have heard, "Well everybody does it", but this is the only time anybody ever put it in writing. And I think that is extremely disturbing, because everybody doesn't do it. And in fact, I know of very few people who do do it. And the fact that so few people do that sort of thing, that the ones who do do it become the exception rather than the rule, the ones that are talked about over coffee or at cocktail parties or whatever.

So the reputation of the political process of the Senate has suffered, and for the political process to work, the citizens must maintain some level of confidence in our system of legislation and the political institutions. So I would hope that the ethics committee that has been assembled would go forth and would take appropriate actions in this case.

They say the facts of the case have not changed. An apology does not erase those facts, and I would call on Senator Hanna to resign her seat and let it be filled by somebody who will support this institution.
