SUBJECT: Prime Bill Sponsorship 1997 through 2009

This memorandum lists bills and resolutions that you sponsored during your tenure at the General Assembly. Table 1 lists the bills for which you were the prime sponsor as a State Senator from 2003 through 2009. You were the prime sponsor of a total of 144 bills, memorials, and resolutions during this time. Of this number, 131 were bills and 12 were either resolutions or memorials.

Table 2 lists the bills for which you were the prime sponsor as a State Representative from 1997 through 2002. You were the prime sponsor of a total of 51 bills, memorials, and resolutions during this time. Of this number, 46 were bills and 5 were either resolutions or memorials.
