## **MEMORANDUM**

**SUBJECT:** Prime Bill Sponsorship from 2004 through March 2009

This memorandum lists bills and resolutions that you sponsored during your tenure at the General Assembly. Table 1 lists the bills for which you were the prime sponsor as a State Representative from 2004 through 2009. You were the prime sponsor of a total of 104 bills, memorials, and resolutions during this time. Of this number, 89 were bills and 15 were either resolutions or memorials.
