SUBJECT: Bill Sponsorship—Representative Lynn Hefley

This memorandum lists bills and resolutions that you sponsored during your tenure at the General Assembly. Information used to compile this listing came from House and Senate Journals for each year that you served as a state representative.

Table 1 presents the bills for which you were the prime sponsor from 1998 through 2006. You were the prime sponsor of a total of 128 bills and resolutions during this time. Of this number, 114 were bills and 14 were either resolutions or memorials.
