SUBJECT: Prime Bill Sponsorship 2001 through 2010

This memorandum lists bills and resolutions for which you were the prime sponsor during your tenure at the General Assembly. Also included is a copy of the last version of each bill and associated fiscal note.

Table 1 lists the bills for which you were the prime sponsor as a State Senator from 2006 through 2010. You were the prime sponsor of a total of 55 bills, memorials, and resolutions during this time. Of this number, 42 were bills and 13 were either resolutions or memorials.

Table 2 lists the bills for which you were the prime sponsor as a State Representative from 2001 through 2005. You were the prime sponsor of a total of 39 bills, memorials, and resolutions during this time. Of this number, 31 were bills and 8 were either resolutions or memorials.
