SUBJECT: Bill Sponsorship—Senator Dan Grossman

This memorandum lists bills and resolutions that you sponsored during your tenure at the General Assembly. Information used to compile this listing came from House and Senate Journals for each year that you served as a state representative and state senator.

Table 1 presents the bills for which you were the prime sponsor from 2003 through 2006 in the Senate. Table 2 lists the bills for which you were prime sponsor from 1997 through 2002 in the House of Representatives. You were the prime sponsor of a total of 167 bills and resolutions during this time. Of this number, 133 were bills and 34 were either resolutions or memorials.
