SUBJECT: Prime Bill Sponsorship 1999 through 2002 and 2003 through 2010

This memorandum lists bills and resolutions that you sponsored during your tenure at the General Assembly. Table 1 lists the bills for which you were the prime sponsor as a State Senator from 2003 through 2010. You were the prime sponsor of a total of 312 bills, memorials, and resolutions during this time. Of this number, 274 were bills and 38 were either resolutions or memorials.

Table 2 lists all the bills for which you were the prime sponsor as a State Representative from 1999 through 2002. You were the prime sponsor of a total of 37 bills, memorials, and resolutions during this time. Of this number, 29 were bills and 8 were either resolutions or memorials.
