SENATE JOINT RESOLUTION NO. 13

WHEREAS, The venerable Harry M. Locke is now in the sixth term of a long and distinguished career in the Senate of the General Assembly of the State of Colorado; and

WHEREAS, During his tenure in the Senate, the Honorable Harry M. Locke has served with distinction the county of Clear Creek; and

WHEREAS, During that time, it was determined that the State of Colorado should build a dam near Georgetown, the historic county seat of Clear Creek County and erstwhile capital of our state; and

WHEREAS, The Honorable Harry M. Locke was instrumental in obtaining the General Assembly's approval and eventual funding for that dam; and

WHEREAS, The Georgetown Dam was accordingly constructed; and

WHEREAS, The Georgetown Dam was subsequently destroyed by a natural disaster; and

WHEREAS, The Georgetown Dam has now been rebuilt, largely due to the perseverance and dedication of the Honorable Harry M. Locke; and

WHEREAS, It is fitting and proper that Senator Harry M. Locke's long and difficult advocacy of the dam at Georgetown be recognized by the Senate and the people of Colorado; now, therefore,

Be It Resolved by the Senate of the Forty-ninth General Assembly of the State of Colorado, the House of Representatives concurring herein:

That the Division of Wildlife is hereby requested to rename the dam at Georgetown the Harry M. Locke Dam.

Be It Further Resolved, That copies of this Resolution be transmitted to the chairman of the Wildlife Commission.
