SUBJECT: Bill Sponsorship

This memorandum lists bills and resolutions that you sponsored during your tenure at the General Assembly. Table 1 lists the bills for which you were the prime sponsor during your time in the Senate from 2001 through 2008. You were the prime sponsor of a total of 157 bills, memorials, and resolutions during this time. Of this number, 131 were bills and 26 were either resolutions or memorials.

Table 2 lists the bills for which you were the prime sponsor during your time in the House of Representatives from 1993 through 2000. You were the prime sponsor of a total of 93 bills, memorials, and resolutions during this time. Of this number, 80 were bills and 13 were either resolutions or memorials.
