**MEMORANDUM**

**SUBJECT:** Prime Bill Sponsorship 1993 through 1996, 2003 through 2010

This memorandum lists bills and resolutions that you sponsored during your tenure at the General Assembly. Table 1 lists the bills for which you were the prime sponsor as a State Representative from 2003 through 2010. You were the prime sponsor of a total of 108 bills, memorials, and resolutions during this time. Of this number, 68 were bills and 40 were either resolutions or memorials.

Table 2 lists the bills for which you were the prime sponsor as a State Senator from 1993 through 1996. You were the prime sponsor of a total of 22 bills, memorials, and resolutions during this time. Of this number, 21 were bills and 1 was a resolution.
