CONCERNING MEMORIALIZING FORMER SENATOR ROY H. SHORE

WHEREAS, By the Will of Divine Providence, our beloved former member, the Honorable Roy H. Shore, departed this life on October 6, 2005, at the age of 74; and

WHEREAS, Senator Shore was born January 23, 1931, in Montrose, Colorado; and

WHEREAS, A graduate of Regis Jesuit High School and the University of Santa Clara in California, Senator Shore received his medical degree from the University of Colorado; and

WHEREAS, While completing an internship in Flint, Michigan, he met his wife, Mary Studer; and

WHEREAS, Senator Shore served in the United States Army as a medical officer at the Presidio in San Francisco; and

WHEREAS, The Shore Family moved to Denver in order for Senator Shore to finish his residency in internal medicine and, later, to Greeley, where he practiced medicine until 1997; and

WHEREAS, In 1974, Senator Shore was named Physician of the Year by the Colorado Medical Society; and

WHEREAS, Senator Shore began his political career in 1967 when he was elected to represent Weld County in the Colorado House of Representatives; and

WHEREAS, While a member of the Colorado House of Representatives, Senator Shore served on several committees, including Health, Welfare, and Institutions; Education; Game, Fish, and Parks; Appropriations; Labor and Employment Relations; Finance; and Transportation and Highways; and

WHEREAS, During his period of public servitude, Senator Shore sponsored several pieces of legislation dealing with health care and organ donation; and

WHEREAS, In 1980, Senator Shore was appointed to fill a vacancy in the Colorado Senate, which he held until accepting a position as a regent of the University of Colorado; and

WHEREAS, Senator Shore was a man of great stature, both physically and in the way he lived his life; and

WHEREAS, It is fitting that we, the members of the Sixty-fifth General Assembly, pay tribute to the dedicated public service of Senator Shore and
