WHEREAS, Representative Moellenberg was born July 5, 1936, in Idalia, Colorado; and

WHEREAS, He graduated from Kirk High School in 1954 and went on to earn a bachelor's degree from Colorado State University in animal production; and

WHEREAS, Representative Moellenberg was a farmer and rancher and began his career in politics when, in 1966, he was appointed to the Yuma County Board of Commissioners; and

WHEREAS, He was then elected to the position of county commissioner, where he served from 1966 to 1973 and from 1981 to 1990; and

WHEREAS, Representative Moellenberg was first elected to the House of Representatives in 1990 and was regarded as an expert on southeastern Colorado water and agricultural issues; and

WHEREAS, He served on numerous committees, including Agriculture, Livestock, and Natural Resources, Transportation and Energy, and Education, where he served as Vice-chairman; and

WHEREAS, Representative Moellenberg also served as president of the Yuma County Farm Bureau and chairman of the Yuma County Republican Party, and was honored with the Distinguished Service Award from Colorado Counties, Inc.; and

WHEREAS, It is fitting that we, the members of the House of Representatives of the Sixtieth General Assembly, pay tribute to the years of dedicated service of Representative Moellenberg and express our deep regret and sorrow occasioned by his death; now, therefore,
