SUBJECT: Bill Sponsorship

This memorandum lists bills and resolutions that you sponsored during your tenure at the General Assembly. Table 1 lists the bills for which you were the prime Senate sponsor from 2001 through 2008. You were the prime sponsor of a total of 146 bills, resolutions, and memorials during this time. Of this number, 112 were bills and 34 were either resolutions or memorials.
