SUBJECT: Bill Sponsorship

This memorandum provides a list of bills and resolutions that you sponsored during your tenure at the General Assembly as both a Representative and a Senator. Information used to compile this listing came from House and Senate Journals.

Table 1 presents the bills for which you were the prime sponsor from 1983 through 2004. You did not serve in the 55th General Assembly – 1985-1986. You were the prime sponsor of a total of 326 bills and resolutions from 1983 through 2004. Of this amount, 305 were bills and 21 were either resolutions or memorials.
