WHEREAS, By the Will of Divine Providence, our former member, the Honorable Bryan S. Sullivant, departed this life on September 9, 2006, at the age of 51; and

WHEREAS, Senator Sullivant was born on June 13, 1955, in Rochester, Minnesota; and

WHEREAS, Senator Sullivant served as vice president of the Plains Metro District, vice president of the Summit School District, and president of the Denver Young Republicans; and WHEREAS, In 1994, Senator Sullivant was elected to the Colorado House of Representatives where he served until 1999, and he was appointed to the Colorado Senate in 1999 and served until 2000; and

WHEREAS, In his first term, Senator Sullivant was named House Freshman Legislator of the Year and won many statewide awards for legislative excellence; and

WHEREAS, In 1999, Senator Sullivant served as House Assistant Majority Leader; and

WHEREAS, Senator Sullivant represented Boulder, Clear Creek, Gilpin, Jefferson, and Summit Counties; and

WHEREAS, Senator Sullivant spearheaded efforts to put comprehensive growth management legislation and growth issues on the agenda of the General Assembly, introduced a number of bills to manage growth by balancing state leadership with local decision making and economic development with the preservation of the state's natural beauty, and, during the 1999 legislative interim, served as chair of the Committee on Development and Growth in Colorado; and

WHEREAS, Senator Sullivant was a caring, companionate, and supportive friend and father who demonstrated real zest and enthusiasm for life; now, therefore,

Be It Resolved by the House of Representatives of the Sixty-sixth General Assembly of the State of Colorado, the Senate concurring herein:

That, in the death of Bryan S. Sullivant, the people of the state of Colorado have lost an outstanding citizen and public servant, and that we, the members of the Sixty-sixth General Assembly, hereby extend our deepest and heartfelt sympathy to the members of his family and pay tribute to a man who served his community and his state well and faithfully.
