Mr. Stewart, as chairman of the committee appointed to investigate the rumors surrounding Mr. Howland, a member of this body, submitted the following report:

To the Honorable House of Representatives of the Twentieth General Assembly:

Your committee appointed to investigate the report of the rumors of misconduct on the part of William W. Howland, a representative of this House, hereby makes the following report:

On the 3rd day of March, 1915, William W. Howland, a member of this House, rising to a question of personal privilege, requested that an investigation be made of his conduct, and Representative Fincher thereupon moved that a Special Committee be appointed consisting of five members of the House, of which the Speaker was to be a member, to investigate certain rumors published in the daily papers relative to the receipt by said Howland of a package of money alleged to affect certain of his acts concerning legislation; thereupon the motion was adopted by the House and the following members were named to serve on said committee:

Philip B. Stewart, P. D. Nelson, Hugh Taylor, Edward V. Dunklee, Boon Best.

Thereafter, on the 4th day of March, a certain resolution was passed by the House granting said committee certain powers, which consisted mainly of the right to summon witnesses, administer oaths and take testimony, and have all the rights incident and necessary to such an investigation;

Thereafter open hearings were held, and, on to-wit, the 9th day of March, some thirteen witnesses were called before a public

meeting in the chamber of the House of Representatives, among whom particularly were George C. Waterman and William W. Howland, who testified to a story explaining the receipt of the money;

Thereafter, to-wit, on the 12th day of March, another open hearing was held at the same place, and some fourteen witnesses were called to the stand, among whom particularly were Edward Allison, a janitor at the State House, and the aforesaid George C. Waterman and William W. Howland, who testified under oath to an entirely new and different story, and the said William W. Howland thereupon admitted that his explanation under oath at the first hearing was in the main absolutely false, and that he and other witnesses, acting on his behalf and with his consent, had conspired to conceal the truth and by false testimony to deceive and mislead your committee and the House, and the said William W. Howland did therein admit his guilt to the committee of perjury and of subornation of perjury;

That your committee, however, desires to report that at these hearings it was unable to find sufficient evidence that William W. Howland had received said alleged package of money as a bribe, or other improper use relating to his acts as a member of this body, and that we must necessarily limit our findings to the admitted perjury of said member; therefore, be it

Resolved, That upon these findings we herewith recommend that William W. Howland be expelled as a member of this House as being guilty of conduct unbecoming a member of this body, and that his seat be and is hereby declared vacant.
