WHEREAS, By the Will of Divine Providence, our beloved member, the Honorable Charles P. Murphy, has departed this life; and

WHEREAS, The late Senator Murphy served well and faithfully his State and the Counties of Rio Blanco, Moffat, Routt, Jackson and Grand, as a member of the House of Representatives during the 1929 and 1931 sessions of the General Assembly, and as a member of the Senate from 1936 until his recent and untimely death on December 24, 1953; and

WHEREAS, During his years of residence in the State of Colorado, Senator Murphy, not only in his public life but as a prominent cattleman and rancher, endeared himself to the people of the State and to the members of the Colorado General Assembly; and

WHEREAS, It is fitting that the members of this Assembly give recognition to the devoted public service of Senator Murphy and express their deep regret and sorrow occasioned by his death; now, therefore,

*Be It Resolved by the Senate of the Thirty-ninth General Assembly in Second Regular Session Convened, the House of Representatives concurring herein:*

That in the death of Senator Murphy, the State of Colorado has lost one of its outstanding citizens, and we, the members of this Assembly, desire hereby to extend our heartfelt sympathy to Mrs. Marie Murphy, his widow, and the other members of his family, and to express our appreciation of the ability and integrity with which he served his State; and

*Be It Further Resolved,* That this Memorial be spread upon the Journals of the Senate and House of Representatives, and a copy hereof be transmitted to Mrs. Marie Murphy.
