WHEREAS, By the Will of Divine Providence, our beloved former member, the Honorable Cecil P. Lamb, departed this life at the age of ninety; and

WHEREAS, The late Cecil P. "Doc" Lamb served this state faithfully and represented Morgan and Washington Counties in the House of Representatives from 1953 through 1972; and

WHEREAS, The late Representative Lamb distinguished himself as a member of the House Committees on Rules, Agriculture and Livestock, and Labor and Employment Relations and as a member of the Legislative Council; and

WHEREAS, The late Representative Lamb sponsored major legislation regarding the Gross Ton-mile Tax, Reapportionment, and the Withholding Tax, and fought vehemently to achieve the passage of the Veterinarian Practices Act; and

WHEREAS, The late Representative Lamb attended Colorado A & M, now Colorado State University, from 1912 through 1915, receiving the degree of Doctor of Veterinary Medicine and thereafter practiced his profession as an Army veterinarian in the Vets Corps during World War I and as a private practitioner in Brush, Colorado; and

WHEREAS, The late Cecil P. "Doc" Lamb distinguished himself in community service and civic associations as a Past Master of AF & AM Shrine; the Commander of American Legion Post 68, Brush, Colorado; a member of the Veterinarian Medical Society; and a recipient of the Colorado State University Alumni Achievement Award in 1966; and

WHEREAS, It is fitting that we, the members of the Fifty-fourth General Assembly, give tribute to the devoted public service of the late Representative Lamb and express our deep regret and sorrow occasioned by his death; now, therefore,

Be It Resolved by the House of Representatives of the Fifty-fourth General Assembly of the State of Colorado, the Senate concurring herein:

That, in the death of Representative Lamb, the people of this state have lost a dedicated public servant and outstanding citizen and that we, the members of the Fifty-fourth General Assembly, do hereby extend our deep and heartfelt sympathy to the members of his family and pay tribute to a man of character and ability who served this state well and faithfully.
