**WHEREAS**, During his dedicated career in the General Assembly the strong convictions for good government which he held so dearly influenced the many and varied measures that bore the valued mark of his support, and remain in effect today; and

**WHEREAS**, It is fitting that the members of the Forty-seventh General Assembly give recognition and pay tribute to the devotion and integrity that marked the service of Senator Cheever, and to express their deep sorrow and regret occasioned by his passing; now, therefore,
