WHEREAS, Representative Stevens was a graduate of the University of Colorado Law School and served with the Army in North Africa during World War II; and

WHEREAS, Representative Stevens was elected to the House of Representatives in 1963 and served this state and Eagle County faithfully; and

WHEREAS, It is fitting that we, the members of the Fifty-eighth General Assembly, pay tribute to William F. Stevens for his years of dedicated public service and express our deep regret and sorrow occasioned by his death; now, therefore.
