Dear Governor Owens:

I am honored to submit the 2005 Annual Report (Report) on behalf of the Colorado Division of Banking (Division) for all Colorado state chartered commercial banks, industrial banks, and trust companies, as required by the provisions of Sections 11-102-304, 11-104-403, and 11-109-402, C.R.S. The Report also contains information on money order companies licensed by the Division and other comparative financial information.

The overall condition of Division regulated institutions continued to improve during 2005. Industry earnings, which suffered from the economic downturn in 2002, have consistently improved and aggregate return on assets and return on equity exceeded national averages at year end. Total deposits held by state chartered commercial banks increased 14.5 percent to \$21,978,589,000 and total assets increased \$3.4 billion (15.2 percent) to \$26,075,224,000 as of December 31, 2005. The strong growth was supported by a \$585 million (28.3 percent) increase in capital. Asset quality remained strong, with the ratio of nonperforming assets to total assets a low of 0.55 percent as of December 31, 2005. Total assets and deposits held by the four state chartered industrial banks have remained largely unchanged over the last two years.

Trust assets held by Colorado trust companies increased over \$24 billion during 2005 to \$70,288,731,000. The dramatic increase was largely attributable to the formation of a new trust company, which subsequently acquired a large trust portfolio. Aggregate trust company earnings increased 15.5 percent to \$27,231,000.

I trust the information presented in the Report is helpful to you and your staff.

Division Mission and Structure

The Division is responsible for the regulation of state chartered commercial banks, trust companies, industrial banks, money order companies, money transmitters, and foreign capital depositories. The Division holds charter and license application hearings and issues rules and regulations affecting regulated institutions. Division staff conducts examinations of state chartered institutions and licensees. The Division works closely with the Federal Reserve Bank and the Federal Deposit Insurance Corporation in the regulation of commercial banks and industrial banks and certain federally insured trust companies. The Division is also responsible for the enforcement of the Public Deposit Protection Act to protect public entity deposits held by state and national banks.

The nine-member Colorado State Banking Board (Banking Board) is the policy and rulemaking authority for the Division. The Banking Board consists of five members who are executive officers of commercial banks, an executive officer of an industrial bank, an executive officer of a trust company, and two public members. The Governor appoints Banking Board members to four-year terms. At least two of the commercial bank members must be from institutions with less than \$150 million in total assets. The Banking Board conducts monthly meetings that are open to the public, and the public is encouraged to attend.

The State Bank Commissioner is the administrative head of the Division, responsible for the day-to-day operation of the Division, including personnel matters, records, reports, systems, and procedures. The Commissioner is also responsible for all examination and enforcement functions of the Division, subject to the policy-making and rulemaking authority of the Banking Board. The specific duties and powers of the Commissioner are set forth in Section 11-102-102, C.R.S.

As of December 31, 2005, the Division had 38.5 authorized positions, 29 of which were in the Financial Credit Examiner (FCE) category. Of the 29 FCE classifications, 23 are classified as field examiners, four are Portfolio Managers, one manages applications and complaints, and one is Director of Examinations. The Division also employs one information technology (IT) auditor to conduct IT examinations of financial institutions and data centers that provide IT services to Division-regulated institutions. Other positions include an Operations Manager and administrative and support staff.

The Division is organized into two units, *Examinations* and *Operations*. Within the *Examinations Unit*, supervisory and examination responsibilities for the regulated entities are assigned to four Portfolio Managers. The Portfolio Managers supervise examination teams and are the primary Division contact for supervised institutions. The *Operations Unit* is responsible for applications, automation, policies and procedures, enforcement of the Public Deposit Protection Act, program development, training, internal audit and review, oversight of the administrative staff, and accreditation by the Conference of State Bank Supervisors.

Accreditation, Audit and Sunset Process


The Division's operations are independently reviewed through an accreditation process administered by the Conference of State Bank Supervisors (CSBS). The accreditation program involves annual self evaluations in accordance with a CSBS-developed questionnaire and rating system, complemented by an on-site review conducted by a CSBS review team every five years. The next on-site review of the Division is scheduled to be conducted in 2006. The Division's processes, products, and personnel will be evaluated and rated during the review. The accreditation process not only provides an independent review of Division operations, but also identifies areas for improvement and provides comparisons to other state banking departments. In addition, CSBS accreditation is one factor used by federal regulatory agencies in determining the acceptability of state examinations pursuant to interagency agreements and alternating state/federal examinations.

Division operations and programs are also subject to periodic reviews by the Office of the State Auditor. The overall operations of the Division were audited, in conjunction with the Division of Financial Services, during 2003. The auditors reviewed the Division's regulatory programs, oversight of the Public Deposit Protection Act, and resource utilization. Recommendations intended to improve operations and strengthen regulatory programs are described in the report and have been implemented. Legislative recommendations were included in the Division's sunset bills (see below) and enacted during 2004.

As required by statute, the Department of Regulatory agencies performs Sunset reviews of the functions of the Division and Banking Board with respect to regulatory programs. The results of the review and recommendations are provided to the Colorado General Assembly. If the General Assembly does not pass legislation extending such regulation, the program is repealed by operation of law. The Money Order Act and the Division were set to sunset July 2004, pursuant to Sections 12-52-107 and 11-102-101, C.R.S. Reviews of the Division and the Money Order Act were conducted in 2003, with the final reports issued in October 2003. Continuation of the Division and the Money Transmitters Act, as well as legislative changes recommended in the audit, were included in House Bills 04-1110, 1111, and 1112, which were passed during the 2004 General Assembly and signed by the Governor.


Division Budget and Funding


The Division operates on a July 1 to June 30 fiscal year and is cash funded in advance through semi-annual institution assessments, specialty examination charges, and receipt of application and licensing fees. The Division's approved budget for the 2005-2006 fiscal year is \$3,694,000. The assessment rates and fee structure are reviewed and approved by the Banking Board annually. Institution assessments are the primary funding source. The assessment consists of a base amount plus a sliding scale percentage of assets over an established level. The calculation formula is based on projected funding needs, less application and examination fees. A breakdown of the Division's budget, as well as trend information for revenues, assessment base, and the cash fund balance, is depicted in the following charts.



Reserve Fund Balance

Legislation enacted in 1998 (SB 98-194) required cash funded agencies, having a cash fund balance in excess of 16.5 percent of expenditures as of June 30, 1998, to reduce fees as necessary to lower the cash fund balance to 16.5 percent of expenditures, or less, by the end of the 2000-01 fiscal year. The Division internally targets a cash fund level of 10 percent to avoid inadvertently exceeding the cap; however, due to an unanticipated level of personnel vacancy savings, the Division's cash fund balance as of June 30, 2005, exceeded the 16.5 percent cap. The June 2005 assessment (for the period July 1, 2005 through December 31, 2005) was reduced accordingly to bring the balance back down below the cap and closer to the internal target as reflected in the chart below. The reduction in assessments and utilization of additional cash funds accounts for the drop in fiscal year 2005/2006 revenue depicted in the chart on the preceding page.





The overall condition of Division regulated institutions continued to improve during 2005. The year saw continued growth in total assets and equity, supported by solid asset quality ratios. Industry earnings, which suffered from the economic downturn in 2001 and 2002, have gradually improved. The aggregate return on assets and return on equity for Colorado state chartered banks, industrial banks, and FDIC insured trust companies exceeded national averages at year end. Another positive earning indicator, the ratio of institutions that posted earning gains, exceeded 68 percent as of December 31, 2005, up from a low of 47 percent in 2003. The number of institutions recording a loss also declined to 5.9 percent during the year. Earning gains were buoyed in large part by an improved net interest margin, which increased by 21 basis points during the year. Additionally, net loans and leases as a percentage of total assets, which dropped dramatically during 2002 and 2003, improved to 53.7 percent in 2005. Although this ratio still lags the national average, loan performance indicates that state chartered banks and industrial banks are continuing to lend cautiously and have avoided the problems encountered by more aggressive lenders.


Commercial Banks

Assets held by state chartered banks increased 15.1 percent to \$26,075,224,000 as of December 31, 2005. The industry continued to improve its already strong capital position as the asset growth was supported by a 28.3 percent increase in equity capital. Total deposits increased 14.5 percent to \$21,978,589,000, as state chartered banks continued to increase reliance on other funding sources.

The number of state chartered banks remained the same during the year as a new charter and conversions offset mergers. The following three charts depict the changes in number, total assets, and total equity of state chartered commercial banks over the ten-year period ending December 31, 2005.









Industrial Banks

Industrial banks are differentiated from commercial banks by the types of checking products that can be offered and exemptions from certain ownership restrictions applicable to commercial banks. The industry has evolved from a large number of very small industrial banks focused on low- to moderate-income consumer lending, plagued by severe financial problems in the late 1980s, to a small group of healthy niche lenders. Legislative changes in the last decade removed nearly all statutory and regulatory differences and implemented a requirement that industrial banks protect depositors through retention of FDIC deposit insurance.

Total assets and deposits held by the four state chartered industrial banks remained relatively unchanged.








Trust Companies

State chartered trust companies provide a variety of fiduciary services, including traditional managed trust business, administering self-directed IRA or pension funds, and administration of collective investment funds. Trust companies are authorized to invest in loans, but are prohibited from originating loans. Legislation enacted in 1989 allows state chartered trust companies to become federally insured depository institutions authorized to accept and maintain savings deposits, time deposits, and certificates of deposit. Only trust companies and state and nationally chartered banks authorized to offer fiduciary services are permitted to conduct trust company business in Colorado. As of December 31, 2005, there were two depository trust companies and seven non-depository trust companies in Colorado.

Corporate trust company assets increased by 4.7 percent during the year to \$2,519,665,000, while trust assets increased over \$24 billion during 2005 to \$70,288,731,000. The dramatic increase was largely attributable to the formation of a new trust company, which subsequently acquired a large trust portfolio.








Money Transmitter Companies

As of December 31, 2005, there were twenty-eight organizations licensed under Colorado's Money Transmitter Act. With the exception of governmental organizations and insured financial institutions, licensing is required of any organization selling money orders or travelers checks or transmitting money electronically or by other means in Colorado.

The total dollar amount of money transmitted, and exchange sold or issued in Colorado during 2005 by Colorado licensed money transmitters increased 3.3 percent to \$19.9 billion. Although the number of licensed money transmitters has increased over the last few years, the aggregate amount of exchange sold in Colorado has declined from a high of approximately \$22 billion in 2002, due primarily to reduction in the volume of paper based products, such as travelers checks and money orders, as consumers have come to rely more heavily on credit, debit, and stored value cards.
