SB14-103 Report June 19, 2017



COLORADO Colorado Water Conservation Board Department of Natural Resources

SB14-103 prohibited the sale of new low-efficiency plumbing fixtures in Colorado as of September 1, 2016. Low efficiency fixtures are those that do not comply with the EPA WaterSense program specification. This means that new fixtures have been tested and certified by an accredited third party or are authorized to use the WaterSense label. The fixtures considered in SB14-103 are lavatory faucets, showerheads, flushing urinals, and tank-type toilet or water closets.

Additionally, each manufacturer that sells these fixtures in Colorado is required to file a one-time report with the Colorado Water Conservation Board (CWCB) by March 1, 2017. These reports detail the percentage of low efficiency verses WaterSense fixture sales in Colorado during 2016.

The CWCB worked with Denver Water to create FAQ's for the manufacturers and an online form to report sales percentages. Plumbing Manufacturers International, the plumbing manufacturer's trade organization, assisted in alerting all of their members to the reporting requirement. Eighteen manufacturers submitted reports for their 2016 sales in Colorado. Below are the final percentages for the represented fixture categories. The following page contains the names and origins of the manufacturers that submitted reports.
