Dear Representatives and Senators:

Senate Bill 03-024 gave specific authority to county sheriffs to issue permits for concealed weapons. Colorado Revised Statute 18-12-206 (4) requires that each sheriff submit a report annually to the General Assembly specifying the number of applications for permits received, the number of permits issued, the number of permits denied and the reasons for denial, and the number of permits revoked and the reasons for revocation. The report must be submitted by March 1 of each year.

County Sheriffs of Colorado agreed to collect the data for this report and submit it on behalf of the sheriffs of the state. Attached please find a report that includes the information required for all 64 Colorado counties. Because S.B. 03-0024 became effective in May 2003, this report includes data on permit activity that occurred both before and after the effective date.

The report classifies the reasons for revocation or denial into five categories. "Arrest" includes arrests and convictions for offenses that would prohibit possession of a firearm, or are specifically excluded by S.B. 03-024. "Discretion" includes cases where the sheriff determined that the applicant was a danger to self or others based on documented evidence. "Residency" includes those not qualified because of residence. "Restraining Orders" include persons who were the subject of a temporary restraining order, permanent restraining order or other protective order. "Mental Illness or Addiction" includes persons disqualified because of mental illness or addictions to drugs or alcohol. Although efforts have been made to uniformly describe the reasons for denial and revocation, because of widely varying circumstances some fall into more than one category.
