**SECTION 2.** 24-1-114 (4) (g), Colorado Revised Statutes, is repealed as follows:

**24-1-114. Department of higher education - creation.** (4) For the purposes of section 22 of article IV of the state constitution, the following are allocated to the department of higher education but shall otherwise continue to be administered as provided by law:

(g) The Colorado children's trust fund board, created by article 3.5 of title 19, C.R.S.

**SECTION 3.** 19-3.5-104 (1), Colorado Revised Statutes, is amended to read:

**19-3.5-104.** Colorado children's trust fund board - creation - members. (1) There is hereby created, in the department of higher education, PUBLIC HEALTH AND ENVIRONMENT, the Colorado children's trust fund board. The board shall exercise its powers and duties as if the same were transferred by a type 2 transfer. The board may contract with the department of social work of Colorado state university for administrative and technical support for the board in carrying out its duties and functions.".

Transfer of appropriation.** Any appropriation made in the annual general appropriation act for the fiscal year beginning July 1, 2000, to the department of higher education, Colorado commission on higher education, special purpose, Colorado children's trust fund, and any corresponding FTE, are hereby transferred to the department of public health and environment, for the implementation of this act.
