The determinations required by this paragraph (b) shall be made after considering the financial condition of applicant companies, on-site visits to applicant companies, and joint evaluations thereof by the state board for community colleges and occupational education and the COLORADO office of economic development as joint operators of the program. Training or retraining under the program may include any of the following or any combination thereof:
- There is hereby created in the state treasury the Colorado existing industry training cash fund which THAT shall consist of all moneys credited thereto pursuant to this subsection (4) and as otherwise provided by law.
