"(2) The board shall deposit all of the proceeds from the sale of the right-of-way parcel, as such proceeds become available, into the public buildings trust."

Page 16, strike lines 1 through 5;

"every six months after June 1, 2001, on such matters until all of the transferred parcel has been sold and the proceeds repaid to the capital construction fund and all of the right-of-way parcel has been sold and the proceeds deposited into the public buildings trust by the board."
