After consideration on the merits, the Committee recommends the following:

HB09-1293 be amended as follows:

- 1 Amend printed bill, page 17, line 7, after "MEMBERS", insert "SEVEN OF
- 2 WHOM SHALL BE";
- 3 line 10, strike "FOUR" and substitute "THREE";
- 4 line 22, after "HOSPITAL;", insert "AND";
- 5 strike lines 23 through 27.
- 6 Page 18, strike lines 1 and 2.
- 7 Reletter succeeding sub-subparagraph accordingly.
- 8 Page 18, after line 3, insert the following:
 - 9 "(II) (A) THE PRESIDENT OF THE SENATE SHALL APPOINT ONE
 - 10 MEMBER OF THE ADVISORY BOARD WHO IS EMPLOYED BY A HOSPITAL IN
 - 11 COLORADO.
 - 12 (B) THE SPEAKER OF THE HOUSE OF REPRESENTATIVES SHALL
 - 13 APPOINT ONE MEMBER WHO IS A MEMBER OF THE HEALTH CARE INDUSTRY
 - 14 WHO DOES NOT REPRESENT A HOSPITAL OR HEALTH INSURANCE CARRIER;
 - 15 (C) THE MINORITY LEADER OF THE SENATE SHALL APPOINT ONE
 - 16 MEMBER WHO IS A CONSUMER OF HEALTH CARE AND WHO IS NOT A
 - 17 REPRESENTATIVE OR AN EMPLOYEE OF A HOSPITAL, HEALTH INSURANCE



1 CARRIER, OR OTHER HEALTH CARE INDUSTRY ENTITY; AND

2 (D) THE MINORITY LEADER OF THE HOUSE OF REPRESENTATIVES
3 SHALL APPOINT ONE MEMBER WHO IS A REPRESENTATIVE OF A BUSINESS
4 THAT PURCHASES HEALTH INSURANCE FOR ITS EMPLOYEES."

5 Renumber succeeding subparagraphs accordingly.

6 Page 18, strike lines 10 through 17, and substitute the following:

7 "(IV) MEMBERS OF THE ADVISORY BOARD SHALL SERVE AT THE
8 PLEASURE OF THE APPOINTING OFFICIAL. IN MAKING HIS OR HER
9 APPOINTMENTS, THE GOVERNOR SHALL SPECIFY THAT THREE MEMBERS
10 SHALL SERVE INITIAL TERMS OF TWO YEARS AND TWO MEMBERS SHALL
11 SERVE INITIAL TERMS OF THREE YEARS. THE MEMBER APPOINTED BY THE
12 PRESIDENT OF THE SENATE SHALL SERVE AN INITIAL TERM OF THREE
13 YEARS. THE MEMBER APPOINTED BY THE MINORITY LEADER OF THE HOUSE
14 OF REPRESENTATIVES SHALL SERVE AN INITIAL TERM OF TWO YEARS. ALL
15 OTHER TERMS INCLUDING TERMS AFTER THE INITIAL TERMS SHALL BE FOUR
16 YEARS. A MEMBER WHO IS APPOINTED TO FILL A VACANCY SHALL SERVE
17 THE REMAINDER OF THE UNEXPIRED TERM OF THE FORMER MEMBER.";

18 line 20, strike "SUB-SUBPARAGRAPHS (A) TO (F) OF" and, after "(I)", insert
19 "OR (II)".
