After consideration on the merits, the Committee recommends the following:

HB09-1326 be amended as follows:

- 1 Amend reengrossed bill, page 5, after line 3, insert the following:
- 2       "(b) BEGINNING WITH THE 2010 GENERAL ELECTION:
- 3           (I) EACH PROPOSED CHANGE TO THE STATE CONSTITUTION,  
4 WHETHER INITIATED BY THE PEOPLE OR REFERRED TO THE PEOPLE BY THE  
5 GENERAL ASSEMBLY, SHALL BE IDENTIFIED ON THE BALLOT AS AN  
6 "AMENDMENT"; AND
- 7           (II) EACH PROPOSED CHANGE TO THE COLORADO REVISED  
8 STATUTES, WHETHER INITIATED BY THE PEOPLE OR REFERRED TO THE  
9 PEOPLE BY THE GENERAL ASSEMBLY, SHALL BE IDENTIFIED ON THE BALLOT  
10 AS A "PROPOSITION".
- 11 Page 6, line 8, strike "(B)" and substitute "(b)".
- 12 Page 7, strike lines 24 through 27.
- 13 Page 8, strike lines 1 through 5.
- 14 Page 10, line 6, strike "STATEWIDE BALLOTS IN ELECTIONS PRIOR TO AND";  
15 line 7, strike "INCLUDING" and substitute "THE STATEWIDE BALLOT AT".
- 16 Page 17, strike lines 24 and 25.



1 Page 27, line 19, strike "LICENSE IF:" and substitute "LICENSE:";

2 strike lines 20 and 21 and substitute the following:

3 "(I) UNLESS THE PETITION ENTITY AGREES THAT IT SHALL NOT PAY  
4 A CIRCULATOR MORE THAN TWENTY PERCENT OF HIS OR HER  
5 COMPENSATION ON A PER SIGNATURE OR PER PETITION BASIS; OR";

6 line 22, strike "NO" and substitute "IF NO".

7 Page 30, after line 17, insert the following:

8 "SECTION 20. 32-9-119.3 (2), Colorado Revised Statutes, as  
9 enacted by Senate Bill 09-108, enacted in 2009, is amended to read:

10 "32-9-119.3. Elections for sales tax rate increase. (2) A ballot  
11 question submitted pursuant to subsection (1) of this section shall be  
12 submitted at a general election or an election held on the first Tuesday of  
13 November in an odd-numbered year that is conducted in accordance with  
14 the "Uniform Election Code of 1992", articles 1 to 13 of title 1, C.R.S.  
15 The secretary of state shall determine the identifying numbering or  
16 lettering of such a ballot question, and the question shall be printed upon  
17 the ballot immediately following any statewide issues and questions  
18 AMENDMENTS AND PROPOSITIONS."

19 Renumber succeeding sections accordingly.

20 Page 31, line 16, strike "11" and substitute "12".
