After consideration on the merits, the Committee recommends the following:

SB09-104 be amended as follows:

1 Amend printed bill, strike everything below the enacting clause and
2 substitute the following:

3 "SECTION 1. 26-5-101 (3) (m) and (3) (n), Colorado Revised
4 Statutes, are amended, and the said 26-5-101 (3) is further amended BY
5 THE ADDITION OF A NEW PARAGRAPH, to read:

6 **26-5-101. Definitions.** As used in this article, unless the context
7 otherwise requires:

8 (3) "Child welfare services" means the provision of necessary
9 shelter, sustenance, and guidance to or for children who are or who, if
10 such services are not provided, are likely to become neglected or
11 dependent, as defined in section 19-3-102, C.R.S. "Child welfare
12 services" includes but is not limited to:

13 (m) Administration and support functions; ~~and~~

14 (n) Services described in section 19-3-208, C.R.S., AND

15 (o) (I) PROVISION OF VERIFIABLE DOCUMENTS TO:

16 (A) YOUTH IN FOSTER CARE WHO PLAN TO EMANCIPATE FROM
17 FOSTER CARE ON OR BEFORE HIS OR HER SEVENTEENTH BIRTHDAY; OR

18 (B) ANY OTHER YOUTH IN FOSTER CARE BEFORE HIS OR HER



1 EIGHTEENTH BIRTHDAY.

2 (II) VERIFIABLE DOCUMENTS SHALL INCLUDE, BUT NEED NOT BE
3 LIMITED TO A CERTIFIED COPY OF THE YOUTH'S BIRTH CERTIFICATE AND A
4 SOCIAL SECURITY CARD. THE COST OF PROVIDING THE VERIFIABLE
5 DOCUMENTS SHALL BE BORNE BY THE COUNTY OR CITY AND COUNTY
6 RESPONSIBLE FOR THE YOUTH'S FOSTER CARE AND NOT BY THE YOUTH
7 RECEIVING THE DOCUMENTS.

8 **SECTION 2. Act subject to petition - effective date.** This act
9 shall take effect at 12:01 a.m. on the day following the expiration of the
10 ninety-day period after final adjournment of the general assembly that is
11 allowed for submitting a referendum petition pursuant to article V,
12 section 1 (3) of the state constitution, (August 4, 2009, if adjournment
13 sine die is on May 6, 2009); except that, if a referendum petition is filed
14 against this act or an item, section, or part of this act within such period,
15 then the act, item, section, or part, if approved by the people, shall take
16 effect on the date of the official declaration of the vote thereon by
17 proclamation of the governor."
