HB09-1202 be amended as follows:

- 1 Amend the Business Affairs and Labor Committee Report, dated
 2 February 18, 2009, page 1, line 6, strike "A NEW PARAGRAPH" and
 3 substitute "THE FOLLOWING NEW PARAGRAPHS";
- 4 line 8, strike ""To" and substitute "To";
- 5 line 11, strike "INJURY." and substitute "INJURY;
- 6 (o) TO FAIL TO INCLUDE IN A CONTRACT FOR FUNERAL SERVICES
 7 THE FOLLOWING STATEMENT: "INQUIRIES REGARDING YOUR
 8 FUNERAL AGREEMENT MAY BE DIRECTED TO THE
 9 DEPARTMENT OF REGULATORY AGENCIES", ALONG WITH THE
 10 CURRENT ADDRESS OR TELEPHONE NUMBER OF THE DEPARTMENT OF
 11 REGULATORY AGENCIES.".
- 12 Page 2 of the committee report, strike line 1 and substitute the following:
- 13 "Page 10, line 1, after the period, add "A DESIGNEE SHALL:
- 14 (a) BE AT LEAST EIGHTEEN YEARS OF AGE;
- 15 (b) HAVE AT LEAST TWO YEARS' EXPERIENCE WORKING FOR A
 16 FUNERAL ESTABLISHMENT;
- 17 (c) BE EMPLOYED BY THE REGISTERED FUNERAL ESTABLISHMENT
 18 THAT THE DESIGNEE REPRESENTS;



1 (d) HAVE THE AUTHORITY WITHIN THE FUNERAL ESTABLISHMENT'S
2 ORGANIZATION TO REQUIRE THAT PERSONNEL COMPLY WITH THIS ARTICLE;
3 AND

4 (e) NOT BE DESIGNATED FOR MORE THAN ONE FUNERAL
5 ESTABLISHMENT UNLESS THE ADDITIONAL ESTABLISHMENT IS OPERATED
6 UNDER COMMON OWNERSHIP AND MANAGEMENT AND NO FUNERAL
7 ESTABLISHMENT IS MORE THAN SIXTY MILES FROM ANOTHER
8 ESTABLISHMENT HELD UNDER THE SAME OWNERSHIP CONDITIONS.";

9 strike lines 2 through 6."

10 Page 3 of the committee report, after line 14, insert the following:

11 "Page 17, line 7, after the period, add "A DESIGNEE SHALL:

12 (a) BE AT LEAST EIGHTEEN YEARS OF AGE;

13 (b) HAVE AT LEAST TWO YEARS' EXPERIENCE WORKING FOR A
14 CREMATORY;

15 (c) BE EMPLOYED BY THE REGISTERED CREMATORY THAT THE
16 DESIGNEE REPRESENTS;

17 (d) HAVE THE AUTHORITY WITHIN THE CREMATORY'S
18 ORGANIZATION TO REQUIRE THAT PERSONNEL COMPLY WITH THIS ARTICLE;
19 AND

20 (e) NOT BE DESIGNATED FOR MORE THAN ONE CREMATORY UNLESS
21 THE ADDITIONAL ESTABLISHMENT IS OPERATED UNDER COMMON
22 OWNERSHIP AND MANAGEMENT AND NO CREMATORY IS MORE THAN SIXTY
23 MILES FROM ANOTHER ESTABLISHMENT HELD UNDER THE SAME
24 OWNERSHIP CONDITIONS.";"

25 line 15 of the committee report, strike "Page 17,".

26 Page 7 of the committee report, line 2, strike "A REGISTRATION";

27 line 3 of the committee report, strike "APPLICATION OR";



- 1 line 14 of the committee report, after "MAY" insert "DENY OR";
- 2 lines 27 of the committee report, strike "THE DIRECTOR MAY ENTER THE";
- 3 strike lines 28 and 29 of the committee report.
- 4 Page 8 of the committee report, line 22, strike "SHALL" and substitute
- 5 "MAY".
- 6 Page 12 of the committee report, after line 22, insert the following:
- 7 "Page 28, line 9, strike "offenses committed on or after said" and
- 8 substitute "offenses committed, including failure to register as required
- 9 by this act, on or after January 1, 2010.";
- 10 strike line 10."
