After consideration on the merits, the Committee recommends the following:

SB09-170 be amended as follows:

1 Amend the proposed committee amendment (SB170_L.001), page 3, after
2 line 17, insert the following:

3 "SECTION 3. Article 1 of title 23, Colorado Revised Statutes, is
4 amended BY THE ADDITION OF A NEW SECTION to read:

5 **23-1-129. Study of tuition revenues - report - repeal.** (1) THE
6 DEPARTMENT OF HIGHER EDUCATION, IN COLLABORATION WITH THE
7 GOVERNING BOARDS OF THE STATE INSTITUTIONS OF HIGHER EDUCATION,
8 SHALL CONDUCT A STUDY OF NONRESIDENT STUDENT AND IN-STATE
9 STUDENT TUITION REVENUES RECEIVED BY STATE-SUPPORTED
10 INSTITUTIONS OF HIGHER EDUCATION. ON OR BEFORE FEBRUARY 1, 2010,
11 THE DEPARTMENT OF HIGHER EDUCATION SHALL SUBMIT TO THE
12 EDUCATION COMMITTEES OF THE HOUSE OF REPRESENTATIVES AND THE
13 SENATE, OR ANY SUCCESSOR COMMITTEES, A REPORT OF THE COMPLETED
14 STUDY.

15 (2) THE REPORT, AT A MINIMUM, SHALL SPECIFY:

16 (a) FOR THE 2005-06 THROUGH 2008-09 ACADEMIC YEARS, THE
17 AMOUNT ANNUALLY RECEIVED BY EACH STATE-SUPPORTED INSTITUTION
18 OF HIGHER EDUCATION IN TUITION PAID BY NONRESIDENT STUDENTS
19 ENROLLED IN THE INSTITUTION AND THE AMOUNT ANNUALLY RECEIVED IN
20 TUITION PAID BY STUDENTS ENROLLED IN THE INSTITUTION WHO HAVE
21 IN-STATE TUITION CLASSIFICATION;



1 (b) THE NUMBER OF NONRESIDENT STUDENTS AND THE NUMBER OF
2 STUDENTS WHO HAVE IN-STATE TUITION CLASSIFICATION ENROLLED IN
3 EACH STATE-SUPPORTED INSTITUTION OF HIGHER EDUCATION FOR EACH OF
4 THE 2005-06 THROUGH 2009-10 ACADEMIC YEARS;

5 (c) THE NUMBER OF NONRESIDENT STUDENTS AND THE NUMBER OF
6 STUDENTS WHO HAVE IN-STATE TUITION CLASSIFICATION THAT EACH
7 STATE-SUPPORTED INSTITUTION OF HIGHER EDUCATION ESTIMATES WILL
8 ENROLL FOR THE 2010-11 AND 2011-12 ACADEMIC YEARS AND THE
9 TUITION AMOUNTS EACH STATE-SUPPORTED INSTITUTION OF HIGHER
10 EDUCATION ANTICIPATES RECEIVING FROM NONRESIDENT STUDENTS AND
11 FROM STUDENTS WHO HAVE IN-STATE TUITION CLASSIFICATION IN EACH OF
12 SAID ACADEMIC YEARS;

13 (d) THE REDUCTION IN TUITION REVENUE THAT EACH
14 STATE-SUPPORTED INSTITUTION OF HIGHER EDUCATION WOULD HAVE
15 EXPERIENCED IN EACH OF FISCAL YEARS 2005-06 THROUGH 2008-09 IF THE
16 NONRESIDENT STUDENTS HAD BEEN REQUIRED TO PAY TUITION AT THE
17 RATE CHARGED TO STUDENTS HAVING IN-STATE TUITION CLASSIFICATION;
18 AND

19 (e) THE AMOUNT OF TUITION REVENUE THAT EACH
20 STATE-SUPPORTED INSTITUTION ANTICIPATES LOSING IF NONRESIDENT
21 STUDENTS ARE REQUIRED TO PAY TUITION AT THE RATE CHARGED TO
22 STUDENTS HAVING IN-STATE TUITION CLASSIFICATION IN THE 2009-10
23 THROUGH 2011-12 ACADEMIC YEARS.

24 (3) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2010."
