After consideration on the merits, the Committee recommends the following:

SB09-163 be amended as follows:

1 Amend printed bill, page 73, strike lines 1 through 22 and substitute the
2 following:

3 **"22-11-403. School performance plan - contents.** (1) (a) IF THE
4 STATE BOARD, PURSUANT TO SECTION 22-11-210, DIRECTS A DISTRICT
5 PUBLIC SCHOOL TO ADOPT A PERFORMANCE PLAN, THE LOCAL SCHOOL
6 BOARD, IN ACCORDANCE WITH TIME FRAMES SPECIFIED IN STATE BOARD
7 RULES, SHALL ADOPT A SCHOOL PERFORMANCE PLAN, AS DESCRIBED IN
8 SUBSECTION (3) OF THIS SECTION, FOR THE DISTRICT PUBLIC SCHOOL.

9 (b) THE SCHOOL ACCOUNTABILITY COMMITTEE FOR THE DISTRICT
10 PUBLIC SCHOOL SHALL MAKE RECOMMENDATIONS TO THE LOCAL SCHOOL
11 BOARD CONCERNING THE CONTENTS OF THE SCHOOL PERFORMANCE PLAN.
12 THE LOCAL SCHOOL BOARD SHALL CREATE AND ADOPT THE SCHOOL
13 PERFORMANCE PLAN, TAKING INTO ACCOUNT THE RECOMMENDATIONS OF
14 THE SCHOOL ACCOUNTABILITY COMMITTEE.

15 (c) THE SCHOOL DISTRICT ACCOUNTABILITY COMMITTEE SHALL
16 INCLUDE THE ADOPTED SCHOOL PERFORMANCE PLAN IN THE COMPILATION
17 PREPARED PURSUANT TO SECTION 22-11-302 (1), AND THE LOCAL SCHOOL
18 BOARD SHALL CONSIDER THE ADOPTED SCHOOL PERFORMANCE PLAN IN
19 DEVELOPING THE BUDGET REQUIRED BY SECTION 22-44-108. THE LOCAL
20 SCHOOL BOARD SHALL ENSURE THAT THE SCHOOL PERFORMANCE PLAN IS
21 IN EFFECT FOR THE DISTRICT PUBLIC SCHOOL WITHIN THE TIME FRAMES
22 ESTABLISHED IN STATE BOARD RULES.

1 (2) (a) IF THE STATE BOARD, PURSUANT TO SECTION 22-11-210,
2 DIRECTS AN INSTITUTE CHARTER SCHOOL TO ADOPT A PERFORMANCE
3 PLAN, THE INSTITUTE, IN ACCORDANCE WITH TIME FRAMES SPECIFIED IN
4 STATE BOARD RULES, SHALL ADOPT A SCHOOL PERFORMANCE PLAN, AS
5 DESCRIBED IN SUBSECTION (3) OF THIS SECTION, FOR THE INSTITUTE
6 CHARTER SCHOOL.

7 (b) THE SCHOOL ACCOUNTABILITY COMMITTEE FOR THE INSTITUTE
8 CHARTER SCHOOL SHALL MAKE RECOMMENDATIONS TO THE INSTITUTE
9 CONCERNING THE CONTENTS OF THE SCHOOL PERFORMANCE PLAN. THE
10 INSTITUTE SHALL CREATE AND ADOPT THE SCHOOL PERFORMANCE PLAN,
11 TAKING INTO ACCOUNT THE RECOMMENDATIONS OF THE SCHOOL
12 ACCOUNTABILITY COMMITTEE.

13 (c) THE INSTITUTE SHALL INCLUDE THE ADOPTED SCHOOL
14 PERFORMANCE PLAN IN THE COMPILATION PREPARED PURSUANT TO
15 SECTION 22-11-303 (2) (b). THE INSTITUTE SHALL ENSURE THAT THE
16 SCHOOL PERFORMANCE PLAN IS IN EFFECT FOR THE INSTITUTE CHARTER
17 SCHOOL WITHIN THE TIME FRAMES ESTABLISHED IN STATE BOARD RULES.";

19 Page 74, line 16, strike "(2);" and substitute "(3);";

21 Page 75, strike lines 3 through 24 and substitute the following:

23 PUBLIC SCHOOL TO ADOPT AN IMPROVEMENT PLAN, THE LOCAL SCHOOL
24 BOARD, IN ACCORDANCE WITH TIME FRAMES SPECIFIED IN STATE BOARD
25 RULES, SHALL ADOPT A SCHOOL IMPROVEMENT PLAN, AS DESCRIBED IN
26 SUBSECTION (3) OF THIS SECTION, FOR THE DISTRICT PUBLIC SCHOOL.

27 (b) THE SCHOOL ACCOUNTABILITY COMMITTEE FOR THE DISTRICT

29 BOARD CONCERNING THE CONTENTS OF THE SCHOOL IMPROVEMENT PLAN.
30 THE LOCAL SCHOOL BOARD SHALL CREATE AND ADOPT THE SCHOOL
31 IMPROVEMENT PLAN, TAKING INTO ACCOUNT THE RECOMMENDATIONS OF
32 THE SCHOOL ACCOUNTABILITY COMMITTEE.



1 (c) THE SCHOOL DISTRICT ACCOUNTABILITY COMMITTEE SHALL

3 PREPARED PURSUANT TO SECTION 22-11-302 (1), AND THE LOCAL SCHOOL
4 BOARD SHALL CONSIDER THE ADOPTED SCHOOL IMPROVEMENT PLAN IN
5 DEVELOPING THE BUDGET REQUIRED BY SECTION 22-44-108. THE LOCAL
6 SCHOOL BOARD SHALL ENSURE THAT THE SCHOOL IMPROVEMENT PLAN IS
7 IN EFFECT FOR THE DISTRICT PUBLIC SCHOOL WITHIN THE TIME FRAMES
8 ESTABLISHED IN STATE BOARD RULES.

9 (2) (a) IF THE STATE BOARD, PURSUANT TO SECTION 22-11-210,
10 DIRECTS AN INSTITUTE CHARTER SCHOOL TO ADOPT AN IMPROVEMENT
11 PLAN, THE INSTITUTE, IN ACCORDANCE WITH TIME FRAMES SPECIFIED IN
12 STATE BOARD RULES, SHALL ADOPT A SCHOOL IMPROVEMENT PLAN, AS
13 DESCRIBED IN SUBSECTION (3) OF THIS SECTION, FOR THE INSTITUTE
14 CHARTER SCHOOL.

15 (b) THE SCHOOL ACCOUNTABILITY COMMITTEE FOR THE INSTITUTE
16 CHARTER SCHOOL SHALL MAKE RECOMMENDATIONS TO THE INSTITUTE
