#### **Association Structure**

CPHA draws members from all Colorado counties and several state and local departments. CPHA's advocacy and legislative interests extend through the full range of public health issues in urban, rural, and mountainous communities. In order to expand its network and visibility, CPHA works to establish strategic partnerships with other public and private organizations across the state. CPHA is organized by a Board of Directors and four standing committees that work together to support the membership. Affiliate organizations such as the Public Health Nurses Association (PHNAC) and the Colorado Society for Public Health Education (COSOPHE) are also voting members on the Board of Directors. CPHA welcomes affiliation with other organizations that support public health efforts.
