After consideration on the merits, the Committee recommends the following:

SB09-155 be amended as follows:

1 Amend printed bill, page 3, strike line 7 and substitute the following:

2 "WHICH THE PUBLIC SCHOOL WILL BE LOCATED:

3 (I) REFUSES THE DEDICATION";

4 strike line 9 and substitute the following:

5 "PAYMENT IN LIEU THEREOF; AND

6 (II) AGREES WITH THE BOARD OF THE METROPOLITAN DISTRICT TO:

7 (A) LEASE THE SCHOOL BUILDING FROM THE METROPOLITAN  
8 DISTRICT AND OPERATE THE SCHOOL;

9 (B) AUTHORIZE A CHARTER PURSUANT TO PART 1 OF ARTICLE 30.5  
10 OF TITLE 22, C.R.S., FOR OPERATION OF THE SCHOOL; OR

11 (C) ALLOW THE STATE CHARTER SCHOOL INSTITUTE TO AUTHORIZE  
12 A CHARTER PURSUANT TO PART 5 OF ARTICLE 30.5 OF TITLE 22, C.R.S.,  
13 FOR OPERATION OF THE SCHOOL.

14 (b) A BOARD OF A METROPOLITAN DISTRICT THAT".

15 Reletter succeeding paragraphs accordingly.



- 1 Page 3, line 18, strike "SCHOOL." and substitute "SCHOOL, REGARDLESS OF  
2 WHETHER THE SCHOOL WILL BE OPERATED BY THE SCHOOL DISTRICT OR  
3 PURSUANT TO A CHARTER."
- 4 Page 4, line 17, after the second "BOARD", insert "MAY, AT THE  
5 DISCRETION OF THE SCHOOL DISTRICT BOARD OF EDUCATION, CONTRACT  
6 WITH THE SCHOOL DISTRICT BOARD OF EDUCATION TO LEASE THE  
7 BUILDING TO THE SCHOOL DISTRICT FOR OPERATION OF THE SCHOOL OR";
- 8 line 26, after "APPLICATION,", insert "BUT CONSENTS TO ALLOWING THE  
9 STATE CHARTER SCHOOL INSTITUTE TO AUTHORIZE A CHARTER,".
- 10 Page 5, line 7, strike "C.R.S." and substitute "C.R.S., SO LONG AS THE  
11 SCHOOL DISTRICT BOARD OF EDUCATION HAS CONSENTED TO ALLOWING  
12 THE STATE CHARTER SCHOOL INSTITUTE TO AUTHORIZE THE CHARTER."
- 13 Page 5, line 10, strike "(d)," and substitute "(e),";
- 14 line 13, strike "(d)." and substitute "(e).";
- 15 line 14, strike "(a) TO (d)" and substitute "(a) TO (e)".
- 16 Page 6, line 4, strike "BOUNDARIES." and substitute "BOUNDARIES, SO  
17 LONG AS THE SCHOOL DISTRICT BOARD OF EDUCATION HAS CONSENTED TO  
18 ALLOWING THE INSTITUTE TO AUTHORIZE THE CHARTER."
