HB09-1111 be amended as follows:

- 1 Amend reengrossed bill, page 4, line 10, strike "OR";
- 2 line 11, strike "ASSISTANT." and substitute "ASSISTANT, OR ANY OTHER
- 3 LICENSED HEALTH CARE PROVIDER FOR WHICH THE FEDERAL GOVERNMENT
- 4 AUTHORIZES PARTICIPATION IN A FEDERALLY MATCHED STATE LOAN
- 5 REPAYMENT PROGRAM TO ENCOURAGE HEALTH CARE PROFESSIONALS TO
- 6 PROVIDE SERVICES IN UNDERSERVED COMMUNITIES.".
- 7 Page 6, line 13, strike "AND";
- 8 line 24, strike "25-20.5-605." and substitute "25-20.5-605; AND";
- 9 after line 24, insert the following:
  - 10 "(f) TO SEEK AND ACCEPT PUBLIC OR PRIVATE GIFTS, GRANTS, OR
  - 11 DONATIONS TO APPLY TO THE COSTS INCURRED IN FULFILLING THE DUTIES
  - 12 SPECIFIED IN THIS SECTION AND OTHERWISE ADMINISTERING THE
  - 13 PROGRAMS WITHIN THE OFFICE.".
- 14 Page 8, line 19, strike "OR";
- 15 line 20, strike "ASSISTANT." and substitute "ASSISTANT, OR ANY OTHER
- 16 LICENSED HEALTH CARE PROVIDER FOR WHICH THE FEDERAL GOVERNMENT
- 17 AUTHORIZES PARTICIPATION IN A FEDERALLY MATCHED STATE LOAN
- 18 REPAYMENT PROGRAM TO ENCOURAGE HEALTH CARE PROFESSIONALS TO
- 19 PROVIDE SERVICES IN UNDERSERVED COMMUNITIES.".



- 1 Page 12, line 6, strike "FOURTEEN" and substitute "FIFTEEN".
- 2 Page 18, line 22, strike "EFFECTIVE JULY 1, 2009, THERE IS HEREBY
- 3 TRANSFERRED" and substitute "FOR EACH OF THE 2009-10 AND 2010-11
- 4 FISCAL YEARS, THE STATE TREASURER SHALL TRANSFER".
- 5 Page 19, line 2, strike "THE 2009-10 FISCAL YEAR." and substitute "EACH
- 6 OF THE 2009-10 AND 2010-11 FISCAL YEARS."
