After consideration on the merits, the Committee recommends the following: HB09-1272 be amended as follows: Amend printed bill, page 9, strike lines 4 through 10 and substitute the 1 2 following: 3 "PARAGRAPH (b), "ANNUAL ADJUSTMENT" MEANS AN ANNUAL PAYMENT 4 TO LIMITED GAMING FUND RECIPIENTS LISTED IN SECTION 9 (5) (b) (II) OF 5 ARTICLE XVIII OF THE STATE CONSTITUTION, CALCULATED AS FOLLOWS: (I) FOR REVENUES COLLECTED IN FISCAL YEAR 2009-10, THE 6 7 PAYMENT SHALL EQUAL SIX PERCENT OF THE FIRST YEAR'S LIMITED 8 GAMING REVENUES ATTRIBUTABLE TO EXTENDED LIMITED GAMING. 9 (II) FOR EACH FISCAL YEAR AFTER 2009-10, THE ANNUAL 10 PAYMENT SHALL BE INCREASED OR DECREASED AS FOLLOWS AND SHALL 11 CONSTITUTE THE ANNUAL ADJUSTMENT: 12 (A) FOR ANY YEAR IN WHICH THE ANNUAL GROWTH OF LIMITED 13 GAMING REVENUES ATTRIBUTABLE TO EXTENDED LIMITED GAMING 14 EXCEEDS OR EQUALS SIX PERCENT, ADD AN AMOUNT EQUAL TO SIX 15 PERCENT OF SAID REVENUES; 16 (B) FOR ANY YEAR IN WHICH THE ANNUAL GROWTH IN LIMITED 17 GAMING REVENUES ATTRIBUTABLE TO EXTENDED LIMITED GAMING IS 18 BETWEEN ZERO AND SIX PERCENT, ADD AN AMOUNT EQUAL TO THE 19 ACTUAL PERCENTAGE GROWTH OF SAID REVENUES; 20 (C) FOR ANY YEAR IN WHICH LIMITED GAMING TAX REVENUES
