Amend reengrossed bill, page 10, line 22, after the period, add "IF THE COMMISSION REASONABLY DETERMINES, BASED UPON AN EVIDENTIARY HEARING, INCLUDING A REVIEW OF MITIGATION MEASURES, THAT ADDING RENEWABLE RESOURCES PURSUANT TO THE STANDARD IN SECTION 40-3.3-102 (1) COMPROMISES SYSTEM RELIABILITY OR CONFLICTS WITH RELIABILITY STANDARDS OF THE NORTH AMERICAN ELECTRIC RELIABILITY COUNCIL, THE WESTERN ELECTRIC COORDINATING COUNCIL, OR THE FEDERAL ENERGY REGULATORY COMMISSION, THE COMMISSION SHALL DEFER THAT PORTION OF THE RENEWABLE ENERGY RESOURCES THAT CAUSES THE RELIABILITY PROBLEM UNTIL SUCH TIME THAT THE PROBLEM IS RESOLVED.".

Page 11, strike lines 8 through 12, and substitute the following:

"(13) ELIGIBLE CAPACITY USED TO MEET THE STANDARD SHALL EITHER BE PRODUCED IN COLORADO OR WITHIN FIFTEEN MILES OF COLORADO'S BORDERS. RESOURCES THAT, BEFORE THE EFFECTIVE DATE OF THIS ACT, ARE OWNED BY, UNDER CONTRACT TO, OR THE SUBJECT OF NEGOTIATIONS WITH, A PROVIDER OR AVAILABLE TO A PROVIDER BUT FOR A LACK OF TRANSMISSION CAPACITY SHALL NOT BE SUBJECT TO THIS

Page 12, after line 9, insert the following:

"(16) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ARTICLE BUT SUBJECT TO OTHER APPLICABLE REQUIREMENTS OF THIS TITLE, IF THE COMMISSION DETERMINES, FOLLOWING AN EVIDENTIARY HEARING, THAT THE TOTAL COST OF ELECTRICITY OF A PORTFOLIO OF NEW RENEWABLE RESOURCES EXCEEDS THE TOTAL COST OF ANY OTHER PORTFOLIO OF NEW ELECTRIC RESOURCES REASONABLY AVAILABLE TO THE PROVIDER OF ELECTRIC SERVICE AS PART OF ITS LEAST-COST RESOURCE PLAN, THE  $COMMISSION\,SHALL\,REQUIRE\,THE\,PROVIDER\,TO\,DEFER\,THE\,ACQUISITION\,OF$ THE RENEWABLE ELECTRIC RESOURCE UNTIL SUCH TIME AS THE TOTAL COST DOES NOT EXCEED THAT OF OTHER AVAILABLE RESOURCES. FOR PURPOSES OF THIS SUBSECTION (16), THE TOTAL COST OF ELECTRICITY SHALL INCLUDE ALL REASONABLY KNOWN AND QUANTIFIABLE COSTS OVER THE RESOURCE PLANNING HORIZON, INCLUDING ANCILLARY SERVICE COSTS, THE COSTS OF LEGALLY REQUIRED AVAILABLE CONTROL TECHNOLOGY FOR NEW RESOURCES, AND THE COSTS ASSOCIATED WITH TRANSMISSION.".
