- (c) Any auxiliary facilities of Metropolitan state college of Denver that were a part of any state colleges enterprise established under law in existence prior to the establishment of the board of trustees of Metropolitan state college of Denver in Section 23-54-102 shall, as they relate to Metropolitan state college of Denver, be designated enterprises of the board of trustees of Metropolitan state college of Denver.
- (d) Any auxiliary facilities of Western State College of Colorado that were a part of any state colleges enterprise pursuant to paragraph (g) of subsection (4) of this section in existence prior to the establishment of the board of trustees of Western state college of Colorado in section 23-56-102 shall, as they relate to Western state college of Colorado, be designated enterprises of the board of trustees of Western state college of Colorado.";
