A BILL FOR AN ACT

101 **CONCERNING A PROHIBITION AGAINST THE OFF-SITE ELECTRONIC SALE**
102 **OF LOTTERY TICKETS BY THE COLORADO LOTTERY**
103 **COMMISSION.**

Bill Summary

The Colorado lottery commission is prohibited from authorizing the sale of lottery tickets, including instant scratch game tickets, by means of the internet, telephone, computer, or any other electronic device or equipment that the purchaser can access or use to purchase lottery tickets

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-35-208, **amend**
3 (2) (f) as follows:

4 **24-35-208. Commission - powers and duties - rules.** (2) Except
5 as provided in subsection (3) of this section, rules promulgated pursuant
6 to subsection (1) of this section shall include, but shall not be limited to,
7 the following:

8 (f) Without limit to number, the types of locations at which tickets
9 or shares may be sold; EXCEPT THAT THE COMMISSION SHALL NOT
10 PROMULGATE ANY RULE, ISSUE ANY ORDER, OR ADOPT ANY POLICY OR
11 INTERPRETATION BEFORE JULY 1, 2017, THAT AUTHORIZES OR PERMITS
12 THE PURCHASE OF TICKETS, INCLUDING INSTANT SCRATCH TICKETS, OR
13 SHARES BY MEANS OF THE INTERNET, TELEPHONE, COMPUTER, OR ANY
14 OTHER ELECTRONIC DEVICE OR EQUIPMENT THAT THE PURCHASER CAN
15 ACCESS OR USE TO PURCHASE LOTTERY TICKETS OTHER THAN BY DOING SO
16 PERSONALLY AT A LICENSED LOTTERY SALES AGENT'S PHYSICAL PLACE OF
17 BUSINESS;

18 **SECTION 2. Act subject to petition - effective date.** This act
19 takes effect at 12:01 a.m. on the day following the expiration of the
20 ninety-day period after final adjournment of the general assembly (August
21 6, 2014, if adjournment sine die is on May 7, 2014); except that, if a
22 referendum petition is filed pursuant to section 1 (3) of article V of the
23 state constitution against this act or an item, section, or part of this act
24 within such period, then the act, item, section, or part will not take effect
25 unless approved by the people at the general election to be held in

- 1 November 2014 and, in such case, will take effect on the date of the
- 2 official declaration of the vote thereon by the governor.
