(1) The division shall require proof of ownership for an off-highway
vehicle prior to the initial registration required under this article, but such
proof shall not be dependent upon any certificate of title, and no
certificate of title shall be issued by the division SHALL NOT ISSUE A
CERTIFICATE OF TITLE FOR THE VEHICLE.".

OF TITLING OF OR RECORDING LIENS ON MOTOR VEHICLES.".
